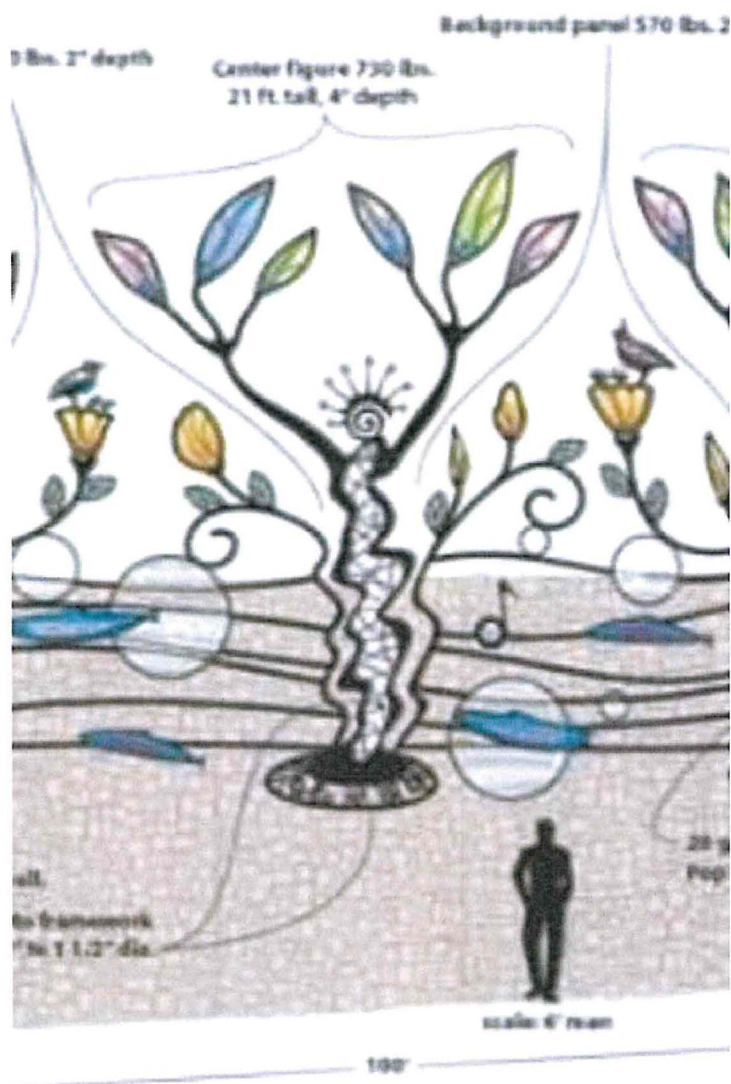
The symbolism on the figures is disturbing. Please review the pedophile symbolism here

The Wopumnes are the documented Nisenan-Mewuk Tribe of John Sutter's diaries and helped John Marshall build the Mill. The Wopumnes Gold Rush people are still alive today and can contribute to artwork to be displayed in their sacred Coloma Valley. The Wopumnes were not consulted by SOFAR regarding this work.

We vote for NO approval.**Wait until the Stay at Home Order is lifted to engage the Tribe in consultation of this artwork.**

By the way the NAHC needs to update their Tribal Consultation list with the Wopumnes for El Dorado County. AB52 provides for the Tribe's protection of their sacred sites. An attorney will be dealing with the NAHC.
