Dr. Laree Kiely, founder and CEO of Kiely Group, provided an overview of the key concepts pertaining to a "Citizen Engagement Survey."

Sherman Fox, Training and Organizational Development Specialist, facilitated the discussion to adjust the proposed Strategic Plan Goals. Supervisor Veerkamp conducted a poll of those present and the majority elected to accept the new goals of:

- Healthy Communities
- Good Governance

The previously proposed Goals of "Effective Services" and "Financial Sustainability" will become subcategories of "Good Governance." The Strategic Plan Goal-Setting Teams will continue to develop their area of focus in preparation for the Strategic Planning Executive Briefing leading up to official adoption of the Strategic Plan by the Board of Supervisors.
