

THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:

RELATED TO REZONING IN THE BUCKEYE AND QUINTETTE AREA, (SILLER BROTHERS):

Section 1. The Official Zoning Map for the Buckeye and Quintette area is hereby amended to rezone the following described lands:
