**RESOLUTION OF VACATION**  
**Abandonment of Easement #08-0010**  
**Swansboro Country Unit 7, Lot 543**  
**Assessor's Parcel Number 085-381-04**  
**Nicholas J. Heyart and Linda L. Heyart**

**WHEREAS**, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

**WHEREAS**, public utility easements, as shown on the Swansboro Country Unit 7 final map, were irrevocably offered in perpetuity to the County of El Dorado in August of 1973, and the Board of Supervisors accepted said offer in May of 1975; and

**WHEREAS**, the Department of Transportation has received an application from Nicholas J. Heyart and Linda L. Heyart, owners of Lot 543 of Swansboro Country Unit 7, also identified as Assessor's Parcel Number 085-381-04, requesting that the County of El Dorado vacate the 15-foot wide El Dorado Irrigation District (EID) easement situated centrally across Lot 543; and

**WHEREAS**, EID has not used said easement for the purpose for which it was dedicated or acquired and finds that no present or future need exists for said easement and does not object to its vacation; and

**WHEREAS**, all other existing easements will remain; and

**WHEREAS**, the Department of Transportation has determined that said easement herein described in Exhibit A and depicted in Exhibit B, has not been used for the purpose for which it was dedicated preceding the proposed vacation, and has no objection.

**NOW, THEREFORE BE IT RESOLVED**, that from and after the date this Resolution is recorded, said 15-foot wide EID easement described in Exhibit A and depicted in Exhibit B, and by reference is made a part hereof, is vacated and no longer constitutes an EID easement. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
