



RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the Board of Supervisors has approved the proposed reorganization of the Community Development Agency into four separate departments, Department of Transportation, Environmental Management Department, Building and Planning Department, and Community Development Services Administration and Finance, and is adding a position of Deputy Chief Administrative Officer to the Chief Administrative Office, effective July 1, 2017; and

WHEREAS, deleting filled positions can potentially result in a Reduction in Force; and

WHEREAS, in accordance with Section 1302 of the County of El Dorado Personnel Rules Resolution #015-2014 applicable to represented employees, and Section 501 of the El Dorado County Salary and Benefits Resolution #323-2001 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions for each department of the County; and

WHEREAS, Resolution #103-2016 established the authorized Personnel Allocation based on the Fiscal Year 2016/2017 Recommended Budget and has been subsequently amended by action of the Board; and

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of El Dorado does hereby amend the Authorized Personnel Allocation Resolution #103-2016 to be effective July1, 2017 with the exception of the addition of the Deputy Chief Administrative Officer that is effective immediately, as set forth below:
