POST-PASSAGE SUMMARY OF ORDINANCE NO. 5224 AMENDING THE EL DORADO COUNTY SCHEDULE OF FEES AND CHARGES FOR SERVICES FOR THE PLANNING AND BUILDING DEPARTMENT

On February 25, 2025, at its regularly scheduled meeting, the County of El Dorado Board of Supervisors held a public meeting and adopted Ordinance 5224 amending uncodified Ordinance 5213, which established fees for the Planning and Building Department including fees related to the Cemeteries Division. The purpose of this Ordinance amendment is to clean up and add fees for the Planning and Building Department related to streamlined projects, stormwater, vacation home rentals and others and to remove the Cemeteries Division fee from the Ordinance to be established by separate resolution.

The Board also voted on whether the adoption of the Ordinance would not be a project within the meaning of California Environmental Quality Act (CEQA), CEQA Guidelines Section 15378(b)(4) and even if it were a Project CEQA would not apply to it because the Ordinance modifies and approves rates and fees within the meaning of Public Resources Code §21080(b)(8)(A-D) and 14 CCR §15273(a)(l)-(4).

The full text of the proposed ordinance is available upon request to the Clerk of the Board. The Ordinance was PASSED AND ADOPTED by the Board of Supervisors of the County of El Dorado at a regular meeting of said Board, held on the 25th day of February 2025, by the following vote of said Board:
