Riverside		x	Ordinance approved 12/10/20. Includes zoning, acreage, and setback restrictions.

San Benito		x	Requires a separate County registration and fee. Ordinance has land use restrictions and exclusion areas. Research is prohibited.

Santa Barbara		x	Currently, only cultivation by a Research Institution. Once the state has a certified hemp program, or when the Federal Rule is final, commercial registration will be available.

Shasta		x	5/19/20- approved indoor nursery & microgreens only. Outdoor to be considered in future after COVID-19.

Tulare		x	Requires a county use permit.

Ventura		x	Ordinance effective 1/15/21. Area and setback restrictions. Use of "low odor" varieties if established. Neighbor approvals.
