Dear Honorable Supervisors,

The undersigned coalition of El Dorado Hills and Cameron Park citizens oppose the "Approved Supervisorial Redistricting Base Map" adopted by the Board of Supervisors at their meeting on June 27, 2011. We contend this map does not serve the best interests of most El Dorado County citizens for the following reasons:

1. **Improper fracture of major communities of interest** including Cameron Park, Bass Lake, Pollock Pines and others. Failure to keep communities of like interest together undermines their collective voice and representation equity. For example, merging 5,000 Cameron Park suburban residents with 31,000 rural residents is unfair to both suburban and rural constituencies. Per Election Code section 21500, "...the board may give consideration to... (c) cohesiveness... and (d) community of interests...". It is imperative that these aspects of redistricting be given all due consideration during the redistricting process.
2. **Failure to take public comment on the June 27 map.** The "June 27 map" was a "surprise map", unknown to the Public until the Supervisors' June 27th meeting. While it was claimed the map was based on public input, the map provided is in no way consistent with the citizen comment documentation on the County redistricting website. Public comment on the "June 27 map" was never solicited. Per Election Code section 21500.1, "The board shall hold at least one public hearing on any proposal to adjust the boundaries of a district..." The "June 27 map" has not been afforded this hearing.
3. **False deadline/rush to judgment.** Per Election Code section 21501, the final redistricting map is not required until "before the first day of November..." There

demonstrably is ample time for the Board of Supervisors to follow due process and include all the communities of El Dorado County in the discussion that will affect us for the next ten years. Per Election Code section 21505, "The board may appoint a committee **composed of residents of the county** to study the matter of changing the boundaries of supervisorial districts." The EDC Citizens for Responsible Government stand ready to participate in such an effort as regards the communities of El Dorado Hills and Cameron Park.

The suburban areas of El Dorado Hills and Cameron Park comprise over 33% of El Dorado County's population. The undersigned coalition is committed to ensuring that all of their combined citizens are united in two Supervisorial Districts of like suburban interests. We further support the aggregation of rural geographies to similarly protect their communities of interests.

The signatories below are unified and resolute that the following actions must be taken:

1. Continue the July 19 Board meeting agenda item to "preview" the "June 27 map" (aka "Adopted Supervisorial Redistricting Base Map" and other names) until such time that a redistricting map is produced that retains all of El Dorado Hills and Cameron Park wholly within two supervisorial districts and does not split Cameron Park.
2. That more redistricting public hearings and/or public participation workshops be conducted by the Board of Supervisors.
3. That the Board of Supervisors form a Residents Redistricting Committee to work with the Board to resolve the shortcomings of the "June 27 map". This committee must have at least ten members including members of EDCCRG and other citizens organizations, such as the Joint Chambers of Commerce, who are engaged in the redistricting process. The committee should be guided by applicable statutes and especially State guidelines one through five of Proposition 11.

The citizens of El Dorado County deserve redistricting that best provides fair representation for the greatest number of citizens.

We look forward to your full and due consideration.


I've just updated www.sierrafoot.org with the final version of my own series of maps. This one, shown at small size below, is identified as the PR2D alternative. My main concern is the area of Districts 1 and 2, but I believe it also is the best candidate map for avoiding splitting communities throughout the County.

This map's graphic rendition is shaded more carefully than the prior PR* maps. A specific change is that it retains shading for all Census Designated Places and incorporated cities, but does not depict boundaries between contiguous CDPs. The main set of contiguous CDP is El Dorado Hills, Cameron Park, Shingle and Springs.

In the PR2D alternative District 1 is entirely within the El Dorado Hills CDP except for a small area on the northeast that serves to balance district populations to within 1% of the target for each district (36,214). Cameron Park and Shingle Springs are entirely within District 2 and comprise the largest population center in that district. District 2 includes the portion of El Dorado Hills which is planned to receive the highest amount of population growth in the coming decade, but which currently has a low population.

Dear Supervisor Nutting:

The El Dorado County Board of Supervisors accepted the Compiled Alternative Redistricting Map and direct staff to adjust the map using precinct lines and property lines to bring forward a final Redistricting Map for final adoption on Monday, June 27th.

The Compiled Alternative Map Redistricting Map was released at the meeting with no opportunity for preview by the voters of this County.

After reviewing the Compiled Alternative Map it appears that you completely misunderstood our concerns. District I with 35,806 El Dorado Hills only people, compared to an estimated 6,000 in District Two hardly addressed our concerns. District II, while much different from the current map, still reflects under representation for El Dorado Hills. This is not what we said, nor is it acceptable.

We respectfully request that the item on final adoption be continued for 3 weeks from the July 19th meeting; Last Item on Agenda, Board Chambers: Preview Final Map.

I am sending out this message to my contacts interested in good government encouraging you all to show up Tuesday at 11:00 am at the Board of Supervisors meeting (dedicated time slot on Agenda) and advocate for a reasonable and fair, non-gerrymandered Redistricting Map.

Paul Raveling's map (attached) is my strong recommendation that the supervisors adopt.

Not only does it treat El Dorado Hills and Cameron Park - Shingle Springs as intact Communities of Interest, but does the same for Diamond Springs-El Dorado, and keeps us rural and not a tacked-on afterthought to Placerville.

Mr. Raveling has done a real service to EDC citizenry with this fair and population-balanced map.

The Board of Supervisors is proposing to adopt a gerrymandered redistricting map that will marginalize the representation of El Dorado Hills and Cameron Park. The Board of Supervisors' proposed map puts part of El Dorado Hills in a half rural district, and splits Cameron Park into two different rural districts. It also puts rural Diamond Springs and El Dorado in with urban Placerville. The Supervisors' proposed Map could be labeled the "Incumbents Protection Map of 2011". The County Board of Supervisors is about to adopt a gerrymandered redistricting map that would marginalize the representation of El Dorado Hills and Cameron Park. The Board of Supervisors proposed map puts part of El Dorado Hills in a half rural district and splits Cameron Park into two different rural districts..

The BOS proposed map is just plain unfair to suburban El Dorado Hills and Cameron Park. Dear Honorable Supervisors,

The undersigned coalition of El Dorado Hills and Cameron Park citizens oppose the "Approved Supervisorial Redistricting Base Map" adopted by the Board of Supervisors at their meeting on June 27, 2011. We contend this map does not serve the best interests of most El Dorado County citizens for the following reasons:

1. **Improper fracture of major communities of interest** including Cameron Park, Bass Lake, Pollock Pines and others. Failure to keep communities of like interest together undermines their collective voice and representation equity. For example, merging 5,000 Cameron Park suburban residents with 31,000 rural residents is unfair to both suburban and rural constituencies. Per Election Code section 21500, "...the board may give consideration to... (c) cohesiveness... and (d) community of interests...". It is imperative that these aspects of redistricting be given all due consideration during the redistricting process.
2. **Failure to take public comment on the June 27 map.** The "June 27 map" was a "surprise map", unknown to the Public until the Supervisors' June 27th meeting. While it was claimed the map was based on public input, the map provided is in no way consistent with the citizen comment documentation on the County redistricting website. Public comment on the "June 27 map" was never solicited. Per Election Code section 21500.1, "The board shall hold at least one public hearing on any proposal to adjust the boundaries of a district..." The "June 27 map" has not been afforded this hearing.
3. **False deadline/rush to judgment.** Per Election Code section 21501, the final redistricting map is not required until "before the first day of November..." There

demonstrably is ample time for the Board of Supervisors to follow due process and include all the communities of El Dorado County in the discussion that will affect us for the next ten years. Per Election Code section 21505, "The board may appoint a committee **composed of residents of the county** to study the matter of changing the boundaries of supervisorial districts." The EDC Citizens for Responsible Government stand ready to participate in such an effort as regards the communities of El Dorado Hills and Cameron Park.

The suburban areas of El Dorado Hills and Cameron Park comprise over 33% of El Dorado County's population. The undersigned coalition is committed to ensuring that all of their combined citizens are united in two Supervisorial Districts of like suburban interests. We further support the aggregation of rural geographies to similarly protect their communities of interests.

The signatories below are unified and resolute that the following actions must be taken:

1. Continue the July 19 Board meeting agenda item to "preview" the "June 27 map" (aka "Adopted Supervisorial Redistricting Base Map" and other names) until such time that a redistricting map is produced that retains all of El Dorado Hills and Cameron Park wholly within two supervisorial districts and does not split Cameron Park.
2. That more redistricting public hearings and/or public participation workshops be conducted by the Board of Supervisors.
3. That the Board of Supervisors form a Residents Redistricting Committee to work with the Board to resolve the shortcomings of the "June 27 map". This committee must have at least ten members including members of EDCCRG and other citizens organizations, such as the Joint Chambers of Commerce, who are engaged in the redistricting process. The committee should be guided by applicable statues and especially State guidelines one through five of Proposition 11.

The citizens of El Dorado County deserve redistricting that best provides fair representation for the greatest number of citizens.

We look forward to your full and due consideration.

Board Member,

Thank you for your hard work and diligence on the redistricting effort taking place in our county currently. I am sure it is a thankless task. I wanted to offer my input on what the new districts should look like for your consideration.

As an El Dorado Hills resident I am very concerned about our representation. It seems to me that there are a variety of interests in our county. The eastern half of our county has different concerns than the western side of our county. Both interests are legitimate. However, the proposed map by the Board has district two representing both El Dorado Hills and rural areas. On many critical growth issues this person would have to have a split personality to do all of his/her constituents justice. It will be impossible for that person to cast one vote in representation of two different (and opposite) views.

After viewing the maps and population data I feel that El Dorado Hills, Cameron Park, Shingle Springs and Rescue have most issues in common. I think this area which constitutes nearly 67,000 people according to the 2010 US Census could easily be represented with two Board Members if a few more out lying areas were brought into the equation. Right now it looks to me like El Dorado Hills is represented by 1.3 board members at best in the current map. And as I said before this partial person cannot represent all areas of his/her district with one vote.

In the 2000 Census EDH had a population of 18,000 and it was given its own representative. Now ten years later we have grown by 2.3 times but are only getting a 0.3 increase in representation. I have included a link to a map that LEGALLY MEETS YOUR OBLIGATION and I believe would suffice for most people in El Dorado Hills (http://www.sierrafoot.org/civics/bos_redistricting/map_images/pr2c_large.jpg). I would possibly move districts 3 and 4 a little to cut down drive time for their board members. The one problem is that in every scenario the Board Member for Tahoe is put at a disadvantage as far as drive time goes. But I cannot see anyway around that scenario. They are just bleeding out too many people.
