**NOTICE OF PUBLIC HEARING REGARDING PROPOSED SOLID WASTE COLLECTION AND MATERIAL RECOVERY FACILITY RATE
INCREASES**

Notice is hereby given that a public hearing will be held at 2:00 PM. on Tuesday, June 22, 2021 by the El Dorado County Board of Supervisors which will be held via Zoom and/or at the Board of Supervisors' Chambers, 330 Fair Lane, Building A, Placerville, California. The public hearing will consider the request by El Dorado Disposal Service to increase solid waste collection rates by 5.52% for Franchise Areas A, B, and C, as well as a 3.75% increase for the Material Recovery Facility, to be effective July 1, 2021.
