Director of Health and Human Services Agency Job Position Interviews

On August 1, 2016, the Mental Health Commission (MHC) ad hoc interview committee participated in an interview panel for the next Director of Health and Human Services Agency (HHSA) position.

On August 10, 2016, the MHC held a special closed session meeting to discuss and review applicants and make a recommendation for the choice of a new Director pursuant to Government Code 54957 (b). After discussion and vote by the Commission, direction was given to the El Dorado County Human Resources Director, to present the Commission's recommendation for Director of Health and Human Services Agency position to the Board of Supervisors.

### Mental Health Commission Training Meeting

On March 5, 2016, members of the Commission participated in training for local Mental Health Boards and Commissions instructed by the California Institute for Behavioral Health Solutions.

The MHC ad hoc Committee reported out to the Commission on April 27 their recommendations for the MHSA 2016-17 Fiscal Year (FY) Plan to be included in the 30 day MHSA FY Plan comment period.

The Mental Health Commission (MHC) held a public hearing on May 25, 2016 for the Mental Health Service Act Fiscal Year 2016-17 Plan Update. The MHC approved the plan after hearing public comment and the Commission's review and discussion.

In November, the County Counsel recommended the Behavioral Health Division identify and complete the first applications for participants in the AOT program.

• Inter Facility Transfers in South Lake Tahoe (IFT).

In July, the Commission passed a motion expressing it's concern that no change be made to IFT in CSA3, South Lake Tahoe, without a satisfactory replacement of services for transport of mentally ill individuals. At the October update, the Mental Health Commission was informed that mental health patients will continue to be transported until the issue is resolved.

### **Looking Ahead 2017**

In November 2016, the Commission discussed the following ideas and goals for 2017:

- Assisted Outpatient Treatment's (AOT) implementation. The program has started in January 2017. The Commission looks forward to it becoming a successful asset to Mental Health Services.
- Advocating for a Mental Health Recovery Center in El Dorado County, allowing for less
  costly in-county placements, instead of sending county residents out of county to Board
  and Care, Institution for Mental Disease Facilities (IMD) and Secure Placement
  Facilities. The result would improve case management and services to clients and keeping
  families together.

The Board of Supervisors has given direction to the Behavioral Health Division to move forward with the concept and bring back a plan for consideration.

- Children's Services, especially AB 403 Continuum of Care Reform.
- Outcome Measures: without them, it cannot be determined if a program is successful or failing, and whether funding is adequate or needs to be increased.
- Peer Programs
- Supportive Housing and employment for clients.

- Maintaining existing Mental Health Services despite new unfunded State Mandated Programs.
- Continuing Mental Health Services at current levels from (MHSA) Mental Health Service Act dollars when traditional funds are expended.
- Increase General Fund dollar allocation to the Behavioral Health Division.
- Continuing Suicide Prevention.

## **Final Thoughts**

In 2016, the Commission was involved in reviewing, evaluating and learning about the many programs and issues that impact Mental Health Services in our County. Commissioners spent a day in training to become educated in performing their duties as Commission members. The informative presentations, topics, discussions, and the Commission's evaluation of services have been valuable in increasing the Commission members' ability to make knowledgeable, informed reports and recommendations to the Board of Supervisors.
