PUBLIC COMMENT PARTICIPATION: If you are joining the meeting via Zoom and wish to make a comment on an item, press the "raise a hand" button. If you are joining the meeting by phone, press *9 to indicate a desire to make a comment. Speakers will be limited to 3 minutes.

Public Forum/Public Comment: The general public may address items not on the agenda during Public Forum/Public Comment. Comments are limited to five minutes per person. The Zoning Administrator reserves the right to waive time limitations. Please note that Public Forum/Public Comment is for comment only. No action will be taken on these items unless they are scheduled on a future agenda.

[24-1838](#) Hearing to consider Green Leaf Drive Project (Tentative Parcel Map P24-0002) request for two (2) commercial parcels of 3.35 acres and 0.32 acre from an existing 3.67-acre parcel on property, identified by Assessor's Parcel Number 327-140-044, consisting of 3.67 acres, is located on the east side of Green Leaf Drive and Mother Lode Drive and immediately south of the intersection with Missouri Flat Road, in the Diamond Springs area, submitted by JAI SHRI RAM HOSPITALITY GROUP, LLC; staff recommends the Zoning Administrator take the following actions:
 - 1) Find Tentative Parcel Map P24-0002 exempt under Section 15315 of the CEQA Guidelines; and
 - 2) Approve Tentative Parcel Map P24-0002, based on the Findings and subject to the Conditions of Approval as presented.

2. [24-1896](#) Hearing to consider Paye Project (Tentative Parcel Map P24-0005) request to create four (4) new residential parcels ranging in size from 5.6 to 7.1 acres and one (1) 78.4-acre remainder parcel, including an offer to the County for a 1.51-acre parcel containing Wentworth Springs Road County maintained right of way on property, identified by Assessor's Parcel Number 061-071-026, consisting of 104.6 acres, is located on the north and south side of Wentworth Springs Road at the intersection with Raintree Road, in the Georgetown Rural Center, submitted by MILLENNIUM PLANNING & ENGINEERING; staff recommends the Zoning Administrator take the following actions:
 - 1) Find that Sections 15162, 15163, and 15164 of the CEQA Guidelines applies to this discretionary review because a prior Initial Study and Mitigated Negative Declaration (Exhibit G) was approved for the existing Parcel Map and there have been no changes to the original project; and
 - 2) Approve Tentative Parcel Map P24-0005, based on the Findings and subject to the Conditions of Approval as presented.
