The County of El Dorado Planning Commission will hold a public hearing in the Planning Commission Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on October 27, 2022, at 8:30 a.m., to consider the following: A request by Cameron Hills 41-20, LLC submitted by Michael C. Stettner, appealing the Planning & Building Department Director's determination that the Final Map (TM-F22-0001) for the Cameron Hills Tentative Subdivision Map (TM08-1473) was not timely filed. The Cameron Hills Final Subdivision Map to allow for the creation of a total of 41 residential lots and five (5) miscellaneous lots. The property, identified by Assessor's Parcel Number 116-010-004, consisting of 20.13 acres, is located south of Berry Road, approximately 234 feet west of the intersection with Cambridge Road, in the Cameron Park Community Region, Supervisorial District 2.
