At its April 24, 2014 meeting, CEDAC passed a Motion to conduct a Special Meeting of CEDAC to discuss making a Motion to the BOS asking them to reconsider Supervisor Brigg's recommendation to approve a grant funding agreement with Marshall Medical Center to support their efforts to expand and enhance the availability of cancer treatment services to county residents. (BOS meeting 4/8/13, Agenda Item number 8, Legistar file number 14-0323.) CEDAC members recognize the availability of quality healthcare an important factor when businesses consider a location for their company. As such, the availability of healthcare is critical to the economic development of the County. The Motion also requested that County staff provide information regarding the County's use of Tobacco Settlement Funds.
