AGREEMENT FOR SERVICES #277-S1010 AMENDMENT III

This Amendment III to that Agreement for Services #277-S1010, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and 3M Electronic Monitoring, Inc., a wholly-owned subsidiary of 3M Company a Delaware Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 1838 Gunn Highway, Odessa, FL 33556 and Agent for Service of Process is *C.T. Corporation System, 818 W. Seventh Street, Los Angeles, CA 90017*; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide electronic monitoring, and global Positioning System (GPS) tracking equipment for the Probation Department and in accordance with Agreement for Services #277-S1010, dated January 27, 2010, Amendment I dated November 17, 2011, and Amendment II dated February 28, 2012, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the term of said Agreement, hereby amending **ARTICLE II, Term**; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #277-S1010 shall be amended a third time as follows:

ARTICLE II




