FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING #9756

THIS FIRST AMENDMENT to that Memorandum of Understanding ("MOU") #9756 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as the "County"), and the El Dorado County Chamber of Commerce, a non-profit corporation duly qualified to conduct business in the State of California, whose mailing address is 542 Main Street, Placerville, California 95667 (hereinafter referred to as the "Chamber"). The entities listed above may collectively be referred to as the "Parties" to this MOU.

RECITALS

WHEREAS, this amendment is to continue a collaborative framework whereby the Chamber provides Film Officer Services in support of commercial film, print, or digital media production activities within El Dorado County, pursuant to Memorandum of Understanding #9756, dated August 12, 2025, incorporated herein and made by reference a part hereof (hereinafter referred to as "MOU");

WHEREAS, the Parties desire to amend the MOU to extend the expiration date of August 11, 2026 for one (1) additional year, amending **Section II, TERM**;

WHEREAS, the Parties desire to amend the MOU to increase the not-to-exceed (NTE) compensation amount of the MOU by \$150,750, for a revised NTE of \$301,500, amending **Section III, PAYMENT**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Chamber mutually agree to amend the terms of the MOU in this First Amendment to Memorandum of Understanding #9756 on the following terms and conditions:

I. **Section II, TERM**, of the MOU is amended in its entirety to read as follows:

II. **TERM**: This MOU shall become effective when fully executed by the Parties hereto and shall expire on August 11, 2027.

II. **Section III, PAYMENT** of the MOU is amended in its entirety to read as follows:

III. **PAYMENT**. County agrees to submit payment to the Chamber in equal quarterly installments of \$37,687.50 each in advance of services for the quarter. The first Quarter 1 payment shall be made within thirty (30) days following the execution of this MOU. Subsequent payments shall be made in accordance with the following schedule until termination of the MOU:

- **Quarter 1**: Within thirty (30) days following execution of this MOU
- **Quarter 2**: No later than October 1, 2025

- **Quarter 3:** No later than January 1, 2026
- **Quarter 4:** No later than April 1, 2026
- **Quarter 5:** Within thirty (30) days following execution of this First Amendment to this MOU.
- **Quarter 6:** No later than October 1, 2026
- **Quarter 7:** No later than January 1, 2027
- **Quarter 8:** No later than April 1, 2027

The total amount of this MOU shall not exceed \$301,500, as amended, inclusive of all costs, taxes, and expenses.

Except as herein amended, all other parts and sections of Memorandum of Understanding #9765 shall remain unchanged and in full force and effect.
