NOTICE IS HEREBY GIVEN that El Dorado County, as Lead Agency, has completed a Draft Environmental Impact Report (Draft EIR) for the Cool General Retail Project.
PROJECT DESCRIPTION: The project applicant proposes to construct a 9,100 SF commercial retail building (Dollar General). The single-story building would have a maximum height of 33 feet. The project design is in the style of new traditional, Western false front architecture. The building has a central entrance, and parapet walls extending along the building facade. The design is responsive to community input and designed to replicate the "Boardwalk" project on the west side of SR 49. The project would include parking for 31 vehicles, a refuse enclosure for solid waste, landscaping, an on-site septic system, and on-site stormwater treatment.
PROJECT LOCATION: The project site fronts the east side of State Highway 49 (Golden Chain Highway) south of the intersection with Northside Drive, north of State Highway 193 (Georgetown Road) approximately 400 feet, in the community of Cool, El Dorado County, California. The project site is identified as Assessor's Parcel Number (APN) 071-500-037.
HAZARDOUS WASTE SITES: The proposed project is not located on any hazardous waste sites lists enumerated under Section 65965.5 of the Government Code.
SIGNIFICANT ANTICIPATED ENVIRONMENTAL EFFECTS: The Draft EIR provides an evaluation of the potential environmental impacts of the proposed project. The Draft EIR has not identified significant and unavoidable environmental impacts related to the project. All identified project-level and cumulative impacts were found to be less-than-significant or could be reduced to a less-than-significant level with

implementation of mitigation measures.
DOCUMENT AVAILABILITY: Copies of the Draft EIR are available for review Monday through Friday, between the hours of 8:00 a.m. and 5:00 p.m., at the County of El Dorado, Planning and Building Department 2850 Fairlane Court, Building C, Placerville CA 95667, except on County holidays.
