RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO CERTIFYING THE FINAL ENVIRONMENTAL IMPACT REPORT PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA), ADOPTING FINDINGS OF FACT AND STATEMENT OF OVERRIDING CONSIDERATIONS, AND ADOPTING THE MITIGATION MONITORING AND REPORTING PROGRAM FOR ASSESSORS PARCEL NUMBERS (APNs): 117-010-032 and a portion of 117-720-012

WHEREAS, on June 29, 2020, the applicant, Winn Communities, submitted an application for a General Plan Amendment (GPA20-0001), Specific Plan (SP20-0001), Rezone (Z20-0005), and Tentative Subdivision Map (TM20-0002) for the Creekside Village Specific Plan Project (“Project”); and

WHEREAS, the project site consists of 208 acres located adjacent to Latrobe Road and approximately 3 miles south of U.S. Highway 50 in the County of El Dorado, California. The project site is identified by El Dorado County APNs 117-010-032 and a portion of 117-720-012; and

WHEREAS, the County, as lead agency pursuant to CEQA, has completed the Final Environmental Impact Report (“Final EIR” or “EIR”) for the Project; and

WHEREAS, this document contains the County’s certification of the EIR, its CEQA Findings of Fact, and its Statement of Overriding Considerations supporting approval of the Project considered in the EIR. The Final EIR has State Clearinghouse No. 2020110052; and

WHEREAS, a Draft Environmental Impact Report (“Draft EIR”) was released for public and agency review on June 20, 2025. The Draft EIR assesses the potential environmental effects of implementation of the Project, identifies means to eliminate or reduce potential adverse impacts, and evaluates a reasonable range of alternatives to the Project; and

WHEREAS, the Final EIR comprises the Draft EIR together with one (1) additional volume that includes the comments on the Draft EIR submitted by interested public agencies, organizations, and members of the public; written responses to the environmental issues raised in those comments; revisions to the text of the Draft EIR reflecting changes made in response to comments and other information; and other minor changes to the text of the Draft EIR. The Final EIR is hereby incorporated in this document by reference; and

WHEREAS, the custodian of the Final EIR is the County of El Dorado Planning Division and the Final EIR is available for public review on the County’s website at: <https://engageeldorado.us.engagementhq.com/creekside-village-specific-plan>; and

WHEREAS, Tribal consultation was requested and is now closed; and

WHEREAS, on November 12, 2025, the Planning Commission held a public hearing on this matter and recommended Board denial; and

WHEREAS, the County of El Dorado Board of Supervisors duly gave notice of public hearing as required by law and on January 27, 2026 duly held a public hearing, received and considered evidence, both oral and documentary; now

THEREFORE, BE IT HEREBY RESOLVED, that the El Dorado County Board of Supervisors authorizes the following CEQA entitlements:

- Certify the Creekside Village Specific Plan Final Environmental Impact Report, October 2025 (SCH# 2020110052) (Attachment P, Exhibit P);
- Adopt the Findings of Fact and Statement of Overriding Considerations (Attachment Q, Exhibit R); and
- Adopt the Mitigation Monitoring and Reporting Program (Attachment Q, Exhibit Q).
