In accordance with Government Code Section 50075, the following annual reporting information is provided for CSA No. 3, for the period: July 1, 2012 - June 30, 2013.

1. CG § 50075.1 (a)

Government Code § 25210.6a expressly authorizes a county service area to levy a special tax for ambulance services subject to voter approval. Resolution No. 300-2000, authorized a special tax to be levied commencing with the 2000-2001 fiscal year and annually thereafter to maintain an appropriate level of advanced life support ambulance service within the Tahoe West Shore area within County Service Area No. 3.

2. CG § 50075.1 (b)

Pursuant to CG § 50075.1 (a) funds collected as a result of this special tax identified in Resolution No. 300-2000 shall be used only for the purpose maintaining an appropriate level of advanced life support ambulance service within the Tahoe West Shore area within County Service Area No. 3.

3. CG § 50075.1 (c)

Special tax collected from Tahoe West Shore area within County Service Area No. 3 are deposited into El Dorado County Index: 408120, Sub object: 0175.
