We just met with Supervisor Briggs and were surprised to hear that the applicant asked that the project be rescheduled to November 4. This will not work for the residents, neighbors of Malcolm Dixon Road, and The Green Valley Alliance. We have been in correspondence with with Supervisor Briggs office previously (below) and we were informed that we would receive proper notification. We have been waiting for a letter to share with our neighbors and Green Valley Alliance. As Brenda Bailey stated, "the public notice process and legal ads contribute to the consideration of the hearing date". We have not yet received any formal notification from the county. We were told that the item would be heard on November 17 but have now learned that 2 Supervisors will not be available. Therefore, we request that the item be moved to December 2nd or December 9th or the 16th as this will provide us with enough time to notify residents that will want to submit their input on this project and arrange to take time off from work and adjust other schedules to attend this hearing.

Please reply as soon as possible with an alternative date and an official letter that can be sent to our neighbors.
