### RESOLUTION FOR PIONEER PARK COMMUNITY CENTER

WHEREAS, Pioneer Park Community Center was built and is available for the public use in those hours not dedicated to County business; and

WHEREAS, The Pioneer Park Community Center will need revenue to administration, operation and maintenance support from the buildings users; and

WHEREAS, The use and users of the building will differ, the following shall be the fee schedule for use of the Pioneer Park Community Center by the public:

General Rules

- A. To qualify for on-going event fee status, groups will be required to sign up for a minimum of 5 meetings.
- B. 4 hour time limits will be set on all ongoing activities, over 4 hrs require additional fees.
- C. All kitchen rental fees are in addition to Main Hall or Conference Room rental fees.
- D. Security deposits will be fully refunded if keys are returned and facilities left in clean condition.
- E. The sale of Alcohol is prohibited for all events at Pioneer Park.
- F. Adult Chaperones will be required for all youth activities.
- G. Liability insurance is required for all scheduled community center events.
