Dear Mr. Turnboo:

I would like to register my strong opposition to the signing of Resolution 027-2021, the subject of Item 34 on the May 4 2021 BOS meeting agenda.

SACOG's website says this:

"This is a four-year pilot aimed at accelerating infill development in the six-county region and complementing that construction with innovative and green mobility solutions that can provide reliable alternatives to driving alone. Infill development, which means building within communities that are already established, is a way to reduce urban sprawl and leapfrog growth."

However, the effect of this program actually would accomplish the opposite of reducing "urban sprawl" as it extends incentives to create greater population density in our (your!) very limited region, one where we residents highly value our all-too-quickly-diminishing rural quality of life. We must push back against Sacramento's self-serving "citifying" of western El Dorado County and place greater value on preserving our own culture.

Simply labeling a program as "green" does not automatically equate to residents' best interests being served. Let's keep in mind El Dorado County's stated vision is for "Safe, healthy and vibrant communities respecting our natural resources and historical heritage" and reject this ill-conceived plan.
