



**RESOLUTION NO.**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS**, in accordance with Section 604 of the County of El Dorado Personnel Rules Resolution #018-2019 applicable to represented and unrepresented employees the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County, and

**WHEREAS**, the County of El Dorado and the El Dorado County Law Enforcement Management Association have an executed Memorandum of Understanding (MOU) for the period January 1, 2022 through December 31, 2023; and

**WHEREAS**, Article 4, Section 1 B. of the MOU provides the wage scale for the Assistant Chief Investigator (District Attorney) classification will match the wage scale for the Sheriff's Lieutenant classification; and

**WHEREAS**, the base salary of the Assistant Chief Investigator (District Attorney) should have been increased by 3.23% effective August 27, 2022, to comply with Article 4, Section 1 B. of the MOU and

**WHEREAS**, the Assistant Chief Investigator (District Attorney) did not receive a wage increase effective August 27, 2022, and

**WHEREAS**, the Assistant Chief Investigator (District Attorney) will receive another wage increase effective pay period 2 of 2023 by operation of El Dorado County Charter Section 504, and

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

**BE IT FURTHER RESOLVED**, that the Board of Supervisors of the County of El Dorado does hereby adopt salary ranges as set forth herein, and amends the salary schedule, effective the pay period including August 27, 2022 and continuing through pay period 01 of 2023 (the pay period including December 17, 2022).

**BE IT FURTHER RESOLVED**, that the Board of Supervisors of the County of El Dorado directs the Payroll Division of the Auditor/Controller's Office to implement the salary changes retroactive to the pay period including August 27, 2022 and continuing through pay period 01 of 2023 (the pay period including December 17, 2022), and compensate employee(s) in the Asst Chief Investigator (D.A.) classification for back pay resulting from the delay in implementation of the required salary increase.
