



Re: Affordable Housing Program Guidelines and Documents

The Department of Human Services, Community Services Division, works with Developers to provide affordable housing units throughout the unincorporated areas of El Dorado County through deed restrictions. Affordable Housing Program Guidelines and accompanying documents have been created to provide guidance to developers of the affordable units and to facilitate the sale of the individual units to eligible buyers.

The attached Deed Restrictions and Affordable Housing Projects Program Guidelines, Affordable Housing Program Buyer's Acknowledgements, Buyer's Resale and Program Restrictions, and the Note Securing the Buyer's Agreement have been previously reviewed by Counsel and all recommended revisions have been made. Final approval of said guidelines and documents must be received from Counsel on the Blue Route Sheet to proceed with obtaining Board of Supervisors approval to implement the Guidelines and execute the documents as necessary.
