Members who are NOT dropped off and/or picked up within the hours defined for the option chosen are subject to an additional fee of \$2 per minute outside of the agreed to option/scheduled time.

NOTE: The majority of participants will be transported to and from the Center using El Dorado Transif. Buses typically arrive between 9:15 and 10:00am and depart in the evening between 4:00 and 4:30pm.

***Fees in each category may be increased by \$1.00 annually on July 1st commencing July 1, 2009.**

IMPORTANT REQUIREMENTS

Participants are required to reserve their days of attendance in advance. The fee is also to be paid in advance of services. Generally, refunds are not available.

For any missed day, the Participant may request a "replacement" or "make up" visit. The replacement visit must be taken within thirty (30) days of the missed visit. In the event of hospitalization, the thirty day make up period can be extended to sixty days by contacting the Program Site Supervisor. The Center will fulfill this request providing its schedule can accommodate it. It is the responsibility of the Participant or his/her Responsible Party to request the replacement visit. If one schedules a make up day and then cancels, the ability to use the make up day is lost.
