OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Authorize the Department of Agriculture and Sheriff's Office of Emergency Services to administer the El Dorado County Disaster Livestock and Agricultural Access Pass Program

WHEREAS, the Department of Agriculture and Sheriff's Office of Emergency Services is bringing to the Board of Supervisors the El Dorado County Disaster Livestock and Agricultural Access Pass Program

WHEREAS, under California Food and Agriculture Code section 2350 the Board of Supervisors may approve the County Agricultural Commissioner, or other designated agency, to establish a county livestock program, and other counties have expanded that program to include commercial agricultural producers; and

WHEREAS, during the Caldor and Mosquito fires access to livestock and crops was vital to maintenance of our agricultural industry and it is critical this is done in a safe and effective manner; and

WHEREAS, the Disaster Agricultural Access Program is a partnership between farmers in El Dorado County and local government agencies to facilitate commercial crop and livestock access in a safe and cooperative manner before, during, and after wildfire and other emergencies; and

WHEREAS, the passes will be administered and approved through the County Agricultural Commissioner's Office and the El Dorado County Sheriffs Office of Emergency Services; and

WHEREAS, to become enrolled in the program, a Commercial Agricultural Operator must complete an initial training, and must complete a refresher training annually;

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors hereby approves the El Dorado County Disaster Agricultural Access Program and the El Dorado County Disaster Livestock Access Program as further described in the attached information packets as Exhibit A and B. The Board of Supervisors delegates to the Department of Agriculture and the Sheriff's Office of Emergency Services the authority to administer the Disaster Agricultural Access Program and to make revisions to the program as necessary to accommodate changes to the law or adjust to a particular emergency or disaster. The Board of Supervisors further delegates to the County Agricultural Commissioner to fully execute the Release of Liability, Indemnity, and Assumption of Risk Agreements in the attached Exhibits A and B and to make minor modifications to that Agreement as necessary, subject to approval by County Counsel as to form.

BE IT FURTHER RESOLVED, that this authorization shall remain in affect indefinitely, unless terminated by the Board of Supervisors, through resolution.

El Dorado County Disaster Livestock Access Program Producer Information Packet

The Disaster Livestock Access Program is a partnership between ranchers in El Dorado County and local government agencies to facilitate livestock access in a safe and cooperative manner before, during, and after wildfire and other emergencies. Supporting agencies include:

- County Department of Agriculture
- County Sheriff's Department
- County Office of Emergency Services
- CalFIRE
- Local Fire Districts
- University of California Cooperative Extension

Due to the scale of operations and the fact that many ranchers operate on a variety of leased and owned land that may or may not be contiguous, evacuating livestock from commercial livestock producers may not be possible in the event of a major incident. Sheltering-in-place may be the best and safest alternative. Safe access by trained and qualified ranch personnel is critical to livestock welfare, firefighter safety, and public safety. This project adapts elements from programs developed in other California Counties, and implements Food and Agricultural Code section 2350. The geographic scope of this project aligns with the CALFIRE administrative unit for the region.

Under this program, a commercial livestock operator who is granted an Agricultural Access Pass may, at the discretion of the relevant emergency services authority, be granted access into evacuation zones, or other restricted areas for purposes of sheltering, moving, transporting, evacuation, feeding, watering, or administering veterinary care to livestock, or providing local expertise to peace officers and emergency personnel. Local expertise shall only be provided upon the request of peace officers and emergency personnel.

To receive a Livestock Access Pass, livestock producers must register and attend a training.

The passes will be administered and approved through the County Agricultural Commissioner's Office and the El Dorado County Sheriff's Office of Emergency Services.

El Dorado County Disaster Livestock Access Program Overview

Qualified Commercial Livestock Producer: For the purposes of this program, a commercial livestock producer is defined as an owner of livestock consisting of 50 head of livestock (including in utero, e.g., 25 bred cows), 100 poultry or rabbits, or 50 beehives or more that reside in El Dorado County for at least a portion of the year, or a person who, through an agreement with that owner of livestock, has authority and is responsible to oversee the care and well-being of the owner's livestock. In addition, a Qualified Commercial Livestock Producer must meet all requirements in Food and Agricultural Code section 2350, as it now reads or may be later amended, including certification of completion of required training.

Livestock Species Covered by Program: This program applies to commercially raised species of livestock, including cattle, sheep, goats, hogs, poultry, rabbits, llamas, alpacas, and bees. "Commercially raised" means the livestock are raised as part of a business.

Application for Registration:

To obtain a Livestock Access Pass, a person must submit an application to the County Agricultural Commissioner's office and include in that application all of the following:

1. Documentation sufficient to demonstrate that the applicant is a commercial livestock producer or a managerial employee of a qualifying livestock producer. This documentation must verify that the applicant owns a minimum of 50 head of livestock (including offspring in utero) (e.g., 25 pregnant cows or ewes), a minimum of 100 poultry or rabbits, or a minimum of 50 beehives. The applicable County Agricultural Commissioner will verify this documentation through the application process, and may request additional clarifying documentation. The required documentation may include, but is not limited to, the following:
 - o Operator Identification Number issued by a county agricultural department
 - o An IRS Schedule F (Form 1040) attesting to the applicant's profit or loss from farming
 - o Assessor's parcel numbers confirming agricultural zoning for the property(ies)
 - o Agricultural land lease documentation
 - o Documentation attesting to the applicant's enrollment in a Williamson Act contract
 - o Documentation from USDA Farm Service Agency attesting that the applicant is a commercial livestock producer
 - o Current registration of a livestock brand with the Bureau of Livestock Identification
2. A list of locations (by APN and/or physical address) owned or managed by the applicant for which disaster access is sought.
3. Certification of completion of fire safety training (see below) of liability.
4. A signed and notarized copy of the Release of Liability, Indemnity, and Assumption of Risks Agreement.

Mandatory Training: To become enrolled in the program, a Commercial Livestock Operator must complete an initial 4-hour training. To maintain a valid pass, a Commercial Livestock Operator must complete a 1-hour refresher training annually.

2023 MANDATORY Training: Initial required trainings will be scheduled in **2023**. *If you have received training in another county, presentation of your Livestock Access Pass from that county will satisfy your training requirement.*

Annual Renewal, Reporting, and Training: Each year, a Commercial Livestock Operator will be required to update/confirm registration information and complete a questionnaire on utilization of the pass. Each year, a Commercial Livestock Operator will also be required to participate in a 1-hour continuing education class prior to pass renewal. Trainings will comply with the curriculum developed by the State Fire Marshal.

Livestock Access Pass Cards and Certification List: Upon submission of a completed application and verification of training, the County Agricultural Commissioner's Office will issue a Livestock Access Pass valid for the current calendar year. This Pass must be presented to law enforcement, fire personnel, or other emergency personnel at a point of entry to gain entrance to an evacuation zone, or other restricted area, caused by a natural disaster or other emergency for the purpose of providing feed, water, medical treatment, and other care to large scale commercial livestock, subject to the discretion of the emergency personnel.

Livestock Access Pass cards are applied for by and distributed to ranchers before a disaster. The application process is designed to confirm that the cardholder is a bona fide agricultural owner-operator or employee whose services are essential to providing protection and care for livestock. Individuals who acquire the Livestock Access Pass should be key personnel who have a working knowledge of the agricultural property, including access to irrigation systems, ranch equipment, and other essential infrastructure. They are aware of or have been trained in emergency procedures and understand that their role is to support the agricultural operation, not to fight fire or act as first responders during disaster.

A managerial employee of a qualifying livestock producer shall not be required by the qualifying livestock producer to obtain a livestock pass. Access to a qualifying livestock producer's ranch by a managerial employee shall be fully voluntary on the part of the managerial employee. A person shall not require any employee to obtain or use a livestock pass or to enter or be present on the livestock producer's ranch property during or following a disaster. A person shall not in any manner discriminate, retaliate, or take any adverse action against an employee for refusing to obtain or use a livestock pass or to enter or be present on the livestock producer's ranch property during or following a disaster.

Conditional Access: Decisions for access can rapidly change during a fire or other natural disaster and will be dependent on safety conditions at the time and upon approval of emergency personnel. Livestock care shall only be provided during daylight hours, and all persons must immediately depart the restricted area by the same route as entry. An escort may be required in any instance and all restricted entry will be dependent on approval of onsite emergency personnel. During initial

evacuation phases, do not expect to gain access to restricted areas by presenting/using the Livestock Access Pass, as during such time all efforts involve the safe removal of people. Once the situation has stabilized, which may take over 24 hours or even days, the Livestock Access Pass will be considered an option by law enforcement, and fire personnel, or other emergency personnel. County Agricultural Departments will coordinate with the incident command system.

During an emergency, do not contact County Animal Control for assistance, or to notify them of your commercial livestock behind fire lines.

Prior Notification: If your livestock are located in an evacuation zone, you will need to notify your interest in using the Livestock Access Pass to gain entrance by contacting the County Agricultural Department. There will be a coordinated effort to consolidate communication with the Sheriff's Office and/or other emergency personnel; once access has been approved by law enforcement or other emergency personnel, the Commercial Agricultural Access Pass holder will be notified. **DO NOT GO TO A ROAD BLOCK AND ATTEMPT TO USE THE COMMERCIAL LIVESTOCK ACCESS PASS WITHOUT PRIOR NOTIFICATION.**

Removal of Livestock: If you intend to remove livestock from the evacuation zone (e.g. for veterinary care or to an alternate location), please provide prior notification to the County Agriculture Department. The intent of this term is to prevent theft of livestock during an emergency. Removing livestock will generally be avoided and will be permitted only if it does not interfere with fire suppression efforts or personnel.

Signage: Commercial Livestock Access Pass holders may be required to place a sign at the entrance to the property where commercial livestock are located in an effort to provide notification to emergency personnel and animal control. The sign will state the animals are under the care of "Commercial Ag Pass Holder."

Livestock Access Pass Database: The Livestock Access Pass registration database will be maintained and updated by OES and County Agricultural Departments. By applying for an Access Pass, you understand that your will be available to key agencies, including, but not limited to, Cal-Fire Amador-El Dorado Unit, California Highway Patrol, County Offices of Emergency Services, and County Sheriff's Offices. The Livestock Access Pass database may also be used for other emergency issues, e.g. livestock out on the road, etc.

During an emergency, law enforcement or other emergency personnel at the point of entry to an evacuation zone will be provided a current list of valid Commercial Livestock Access Pass Holders, permit numbers, along with a sample valid pass, by the County Agricultural Department.

Violations of Pass: The utilization of the Livestock Access Pass is for the purpose of providing of essential care to a commercial agricultural operation, such as watering, harvesting, etc. The Agricultural Access Pass holder may also be asked to provide expertise to peace officers and emergency personnel within the evacuation zone or other restricted area. If a pass holder is found acting outside of the scope of this purpose, then the Livestock Access Pass may be permanently revoked.

Insurance and Risk: Access in an area closed to the public during a disaster may affect the coverage of your property liability insurance, vehicle or equipment insurance, and worker's compensation coverage. As you re-enter your property be aware that hazardous conditions may still exist. Program administrators, collaborators, and trainers shall not be liable for injury or death of someone participating in activities resulting from the inherent risk of re-entering damage areas to provide essential tasks to a commercial agricultural operation.

The Commercial Livestock Operator submitting an application for registration, hereinafter referred to as the "Applicant/Permittee" or "A/P," understands that he or she is requesting access to restricted areas subject to official road closure and not otherwise accessible to the public. In so requesting access, A/P acknowledges the inherent risks and hazards caused by recent catastrophic fires, including the existence of declared local health emergency, which extend to the restricted areas. A/P shall, as a condition of receiving a Pass, sign the Release of Liability, Indemnity, and Assumption of Risk Agreement. A/P further understands that any pass/permit issued covers access only to the location identified in the issued Livestock Access Pass and the direct access route to/from said location; stopping along access routes is strictly prohibited. A/P and its officers, agents, employees, volunteers or representatives shall not wander, loiter, or otherwise meander from the location listed in the issued Livestock Access Pass, and shall be subject to immediate arrest for trespass into restricted areas and prosecuted to the fullest extent of the law.

Annual Report: An annual report on the program will be completed at the end of each calendar year to inform need of program modifications and utilization. The report will be provided to partners, stakeholders, and the County Boards of Supervisors.

Modifications: This is a new program and will be reviewed annually. To improve the program, modifications may be made annually and during the course of the year – in which case, any changes will be provided to the annual Livestock Access Pass holder via email.

Release of Liability, Indemnity, and Assumption of Risks Agreement

In consideration for my participation in the Disaster Livestock Access Program and its associated training course (referred to below as "Program"), the undersigned, on behalf of myself, my heirs, next of kin, spouse, assignees, officers, employees, agents, or volunteers, hereby agree as follows:

Section 1: Release of Liability

I agree to waive, release, forever discharge, and covenant not to sue, or initiate mediation or arbitration with, the County of El Dorado its officers, officials, employees, and volunteers, from any and all actions, causes of actions, claims, suits, contracts, controversies, promises, variances, agreements, trespasses, damages, judgments, executions, and demands whatsoever in law or in equity that I now have or may have in the future, or which any personal representative, successor, heir, assignee of mine in the future can, shall or may have, for any reason or cause whatsoever, including but not limited to any and all claims for death, personal injury, or property damage, that arise out of or in any way relate to my participation in the Program.

I agree that my participation in the Program will at all times be fully voluntary and that under Food and Agricultural Code section 2350 no person may require me to use any pass issued under the Program to enter or be present on the livestock producer's ranch property during or following a flood, storm, fire, earthquake, or other disaster. I understand that County does not recommend that I enter the disaster area for any reason and that my choice do is so is fully voluntary.

I further understand that the claims released in this Agreement include all claims of every nature and kind whatsoever, whether known or unknown, suspected, or unsuspected, and I expressly waive all rights under California Civil Code Section 1542, which provides as follows:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

Civ. Code, § 1542

I acknowledge that I may hereafter discover facts different from, or in addition, those which I now know or believe to be true with respect to the released claims, and that I agree that this Agreement, includes, without limitation, the releases contained herein, shall be and remain effective in all respects notwithstanding such different or additional factors or the discovery thereof.

Section 2: Indemnity

To the fullest extent permitted by law, I agree, on behalf of myself as well as well as my heirs, assigns, officers, employees, agents, or volunteers, to defend at my own expense, indemnify, and hold the County harmless, its officers, employees, agents, and volunteers, against and from any and all liability, claims, suits, losses, damages, or expenses of every name, kind and description, including attorney's fees and costs incurred, brought for, or on account of, injuries to or death of any person, including but not limited to workers, County employees, and the public, or damage to property, or any economic or consequential losses, which are claimed to or in any way arise out of or are connected with the acts or omissions of myself my heirs, assignees, officers, agents, or employees from my participation in the Program hereunder, except for liability, claims, suits, losses, damages or expenses arising from the sole negligence or willful acts of the County, its officers and employees, or as expressly prescribed by statute. This duty of Applicant to indemnify and save County harmless includes the duties to defend set forth in California Civil Code Section 2778.

Section 3: Assumption of Risks

I understand and comprehend the risks associated with my participation in the Program, and in particular my access to disaster areas, and I assume full responsibility for any risk of bodily injury, death, or property damage that may result of my participation in the Program, whether caused by the negligence of the County or otherwise.

Section 4: Term

This Agreement becomes effective on the date of signing by both parties and continues so long as Applicant continues to participate in the Program.

Section 5: Governing Law

Any dispute resolution action arising out of this Agreement, including, but not limited to, litigation, mediation, or arbitration, shall be brought in El Dorado County, California, and shall be resolved in accordance with the laws of the State of California.

Section 6: Attorney Fees

If suit is brought to enforce or interpret any part of this Agreement, or the rights or obligations of any Party, including, but not limited to, an action to recover damages for the breach of this Agreement or to secure specific performance of this Agreement, the prevailing party shall be entitled to recover reasonable attorneys' fees, expenses, and costs.

Section 7: Contract Administrator

The County officer or employee with responsibility for administering this agreement is LeeAnne Mila for El Dorado County, or their successor.

Section 8: Notice

All notices to be given by the parties shall be in writing and served by depositing the same in the United States Post Office, postage prepaid to the appropriate County address listed below, and return recipient requested.

Section 9: Entire Agreement

This document and the documents referred to herein or exhibits hereto are the entire Agreement between the parties, and they incorporate or supersede all prior written or oral agreements or understandings.

Section 10: Waiver

No County officer, director, employee, agent, servant, or other representative may vary the terms and provisions of this document or make any oral or written representation contrary to the provisions of this Agreement or otherwise in connection with the subject matter of this Agreement.

READ THE FOLLOWING CAREFULLY:

By signing below, I have fully read this entire Agreement and fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and intend my signature to be a complete and unconditional release of County to the greatest extent allowed by law.



The passes will be administered and approved through the County Agricultural Commissioner's Office and the El Dorado County Sheriff's Office of Emergency Services.

El Dorado County Disaster Agricultural Access Program Overview

Qualified Commercial Agricultural Producer: For the purposes of this program, the Agricultural Commissioner will determine whether an applicant qualifies as a commercial agricultural producer by verifying through a variety of data sources, such as crop report data, pesticide permit status, organic database, certified producer certificate, or other relevant data sources.

Application for Registration:

To obtain an Agricultural Access Pass, a person must submit an application to the El Dorado County Agricultural Commissioner's office, and include in that application all of the following:

1. Documentation sufficient to demonstrate that the applicant is a commercial agricultural producer or a managerial employee of a qualifying agricultural producer. The County Agricultural Commissioner will verify this documentation through the application process, and may request additional clarifying documentation. The required documentation may include, but is not limited to, the following:
 - Operator Identification Number issued by a county agricultural department
 - An IRS Schedule F (Form 1040) attesting to the applicant's profit or loss from farming
 - Assessor's parcel numbers confirming agricultural zoning for the property(ies)
 - Agricultural land lease documentation
 - Documentation attesting to the applicant's enrollment in a Williamson Act contract
 - Documentation from USDA Farm Service Agency attesting that the applicant is a commercial agricultural producer
 - Organic Registration
 - Certified Producers Certificate
 - State Nursery License

They are aware of or have been trained in emergency procedures and understand that their role is to support the agricultural operation, not to fight fire or act as first responders during disaster.

A managerial employee of a qualifying agricultural producer shall not be required by the qualifying agricultural producer to obtain an agricultural pass. Access to a qualifying agricultural producer's operation by a managerial employee shall be fully voluntary on the part of the managerial employee. A person shall not require any employee to obtain or use an agricultural pass or to enter or be present on the agricultural producer's property during or following a disaster. A person shall not in any manner discriminate, retaliate, or take any adverse action against an employee for refusing to obtain or use an agricultural pass or to enter or be present on the agricultural producer's property during or following a disaster.

Conditional Access: Decisions for access can rapidly change during a fire or other natural disaster and will be dependent on safety conditions at the time and upon approval of emergency personnel. Agricultural asset care shall only be provided during daylight hours, and all persons must immediately depart the restricted area by the same route as entry. An escort may be required in any instance and all restricted entry will be dependent on approval of onsite emergency personnel. During initial evacuation phases, do not expect to gain access to restricted areas by presenting/using the Agricultural Access Pass, as during such time all efforts involve the safe removal of people. Once the situation has stabilized, which may take over 24 hours or even days, the Agricultural Access Pass will be considered an option by law enforcement, and fire personnel, or other emergency personnel. County Agricultural Departments will coordinate with the incident command system.

Prior Notification: If your commercial agricultural operation(s) is located in an evacuation zone, you will need to notify your interest in using the Agricultural Access Pass to gain entrance by contacting the County Agricultural Department. There will be a coordinated effort to consolidate communication with the Sheriff's Office and/or other emergency personnel; once access has been approved by law enforcement or other emergency personnel, the Commercial Agricultural Access Pass holder will be notified. **DO NOT GO TO A ROAD BLOCK AND ATTEMPT TO USE THE COMMERCIAL AGRICULTURAL ACCESS PASS WITHOUT PRIOR NOTIFICATION.**

Agricultural Access Pass Database: The Agricultural Access Pass registration database will be maintained and updated by the County Agricultural Department. By applying for an Access Pass, you understand that your data will be available to key agencies, including, but not limited to, Cal-Fire Amador-El Dorado Unit, California Highway Patrol, County Offices of Emergency Services, and County Sheriff's Offices.

During an emergency, law enforcement or other emergency personnel at the point of entry to an evacuation zone will be provided a current list of valid Commercial Agricultural Access Pass Holders, permit numbers, along with a sample valid pass, by the County Agricultural Department.

Violations of Pass: The utilization of the Agricultural Access Pass is for the purpose of providing of essential care to a commercial agricultural operation, such as watering, harvesting, etc. The Agricultural Access Pass holder may also be asked to provide expertise to peace officers and emergency personnel within the evacuation zone or other restricted area. If a pass holder is found acting outside of the scope of this purpose, then the Agricultural Access Pass may be permanently revoked.

Insurance and Risk: Access in an area closed to the public during a disaster may affect the coverage of your property liability insurance, vehicle or equipment insurance, and worker's compensation coverage. As you re-enter your property be aware that hazardous conditions may still exist. Program administrators, collaborators, and trainers shall not be liable for injury or death of someone participating in activities resulting from the inherent risk of re-entering damage areas to provide essential tasks to a commercial agricultural operation.

The Commercial Agricultural Operator, submitting an application for registration, hereinafter referred to as the "Applicant/Permittee" or "A/P," understands that he or she is requesting access to restricted areas subject to official road closure and not otherwise accessible to the public. In so requesting access, A/P acknowledges the inherent risks and hazards caused by recent catastrophic fires, including the existence of declared local health emergency, which extend to the restricted areas. A/P shall, as a condition of receiving a Pass, sign the Release of Liability, Indemnity, and Assumption of Risk Agreement. A/P further understands that any pass/permit issued covers access only to the location identified in the issued Agricultural Access Pass and the direct access route to/from said location; stopping along access routes is strictly prohibited. A/P and its officers, agents, employees, volunteers or representatives shall not wander, loiter, or otherwise meander from the location listed in the issued Agricultural Access Pass, and shall be subject to immediate arrest for trespass into restricted areas and prosecuted to the fullest extent of the law.

Annual Report: An annual report on the program will be completed at the end of each calendar year to inform need of program modifications and utilization. The report will be provided to partners, stakeholders, and the County Boards of Supervisors.

Modifications: This is a new program and will be reviewed annually. To improve the program, modifications may be made annually and during the course of the year – in which case, any changes will be provided to the annual Agricultural Access Pass holder via email.

Disaster Agricultural Access Program
Release of Liability, Indemnity, and Assumption of Risks Agreement

In consideration for my participation in the Disaster Agricultural Disaster Access Program and its associated training course (referred to below as "Program"), the undersigned, on behalf of myself, my heirs, next of kin, spouse, assignees, officers, employees, agents, or volunteers, hereby agree as follows:

Section 1: Release of Liability

I agree to waive, release, forever discharge, and covenant not to sue, or initiate mediation or arbitration with, the County of El Dorado its officers, officials, employees, and volunteers, from any and all actions, causes of actions, claims, suits, contracts, controversies, promises, variances, agreements, trespasses, damages, judgments, executions, and demands whatsoever in law or in equity that I now have or may have in the future, or which any personal representative, successor, heir, assignee of mine in the future can, shall or may have, for any reason or cause whatsoever, including but not limited to any and all claims for death, personal injury, or property damage, that arise out of or in any way relate to my participation in the Program.

I agree that my participation in the Program will at all times be fully voluntary and that under Food and Agricultural Code section 2350 no person may require me to use any pass issued under the Program to enter or be present on the agricultural producer's property during or following a flood, storm, fire, earthquake, or other disaster. I understand that County does not recommend that I enter the disaster area for any reason and that my choice do is so is fully voluntary.

I further understand that the claims released in this Agreement include all claims of every nature and kind whatsoever, whether known or unknown, suspected, or unsuspected, and I expressly waive all rights under California Civil Code Section 1542, which provides as follows:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

Civ. Code, § 1542

I acknowledge that I may hereafter discover facts different from, or in addition, those which I now know or believe to be true with respect to the released claims, and that I agree that this Agreement, includes, without limitation, the releases contained herein, shall be and remain effective in all respects notwithstanding such different or additional factors or the discovery thereof.

Section 2: Indemnity

To the fullest extent permitted by law, I agree, on behalf of myself as well as well as my heirs, assigns, officers, employees, agents, or volunteers, to defend at my own expense, indemnify, and hold the County harmless, its officers, employees, agents, and volunteers, against and from any and all liability, claims, suits, losses, damages, or expenses of every name, kind and description, including attorney's fees and costs incurred, brought for, or on account of, injuries to or death of any person, including but not limited to workers, County employees, and the public, or damage to property, or any economic or consequential losses, which are claimed to or in any way arise out of or are connected with the acts or omissions of myself my heirs, assignees, officers, agents, or employees from my participation in the Program hereunder, except for liability, claims, suits, losses, damages or expenses arising from the sole negligence or willful acts of the County, its officers and employees, or as expressly prescribed by statute. This duty of Applicant to indemnify and save County harmless includes the duties to defend set forth in California Civil Code Section 2778.

Section 3: Assumption of Risks

I understand and comprehend the risks associated with my participation in the Program, and in particular my access to disaster areas, and I assume full responsibility for any risk of bodily injury, death, or property damage that may result of my participation in the Program, whether caused by the negligence of the County or otherwise.

Section 4: Term

This Agreement becomes effective on the date of signing by both parties and continues so long as Applicant continues to participate in the Program.

Section 5: Governing Law

Any dispute resolution action arising out of this Agreement, including, but not limited to, litigation, mediation, or arbitration, shall be brought in El Dorado County, California, and shall be resolved in accordance with the laws of the State of California.

Section 6: Attorney Fees

If suit is brought to enforce or interpret any part of this Agreement, or the rights or obligations of any Party, including, but not limited to, an action to recover damages for the breach of this Agreement or to secure specific performance of this Agreement, the prevailing party shall be entitled to recover reasonable attorneys' fees, expenses, and costs.

Section 7: Contract Administrator

The County officer or employee with responsibility for administering this agreement is LeeAnne Mila for El Dorado County, or their successor.

Section 8: Notice

All notices to be given by the parties shall be in writing and served by depositing the same in the United States Post Office, postage prepaid to the appropriate County address listed below, and return recipient requested.

No County officer, director, employee, agent, servant, or other representative may vary the terms and provisions of this document or make any oral or written representation contrary to the provisions of this Agreement or otherwise in connection with the subject matter of this Agreement.

By signing below, I have fully read this entire Agreement and fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and intend my signature to be a complete and unconditional release of County to the greatest extent allowed by law.


