Dear Supervisors:

I note the item on your 2/24/2015 agenda for a presentation by the Shingle Springs Band of Miwok Indians for a "Shingle Springs Tribal Outdoor Gun Range." It is my understanding that this is proposed for land immediately to the south of Highway 50 at Shingle Springs Drive.

I'm not sure where to begin on a list of reasons why this seems to be an incredibly poor choice of location for an outdoor gun range, but would start by noting its immediate proximity to a busy highway (Highway 50), a local road with a fair amount of traffic (Shingle Springs Drive), several residential properties that it borders and two elementary schools just a short distance to the south (one of which my daughter attends).

Personally, I have no opposition to the Band having an outdoor gun range somewhere, however I have a hard time imaging a worse place to locate it. I would strongly urge the Board and the County to take whatever actions may be available to ensure that an outdoor gun range is not put at this location.
