Attached is a listing of qualified firms for the categories listed above. Firms are listed in rank order. The Planning & Building Department (Department) and the Purchasing Agent will determine the most appropriate method of consultant selection based on project specific needs.

## **Method 1: RFP**

Depending on the number of qualified firms on the list, the Department may select a minimum of two (2) of the most qualified firms for a specific project and issue a Request for Proposal (RFP). The Department may then interview and negotiate an agreement with the firm that is best able to meet the Department's needs.

## **Method 2: Rotation**

For "as needed" services, the Department will develop a short list of the most qualified firms to perform the work and establish contracts with multiple firms to provide services on a rotational basis.

## **Method 3: Sole Source**

A departmental evaluation committee will review SOQs for the specific discipline needed, select a consultant, and negotiate a contract.

All responses are on file in the Procurement & Contracts Office, and are available for review by appointment between 8:00 a.m. – 12:00 p.m. and 1:00 p.m. – 4:30 p.m., Monday through Friday.
