This means that New Morning is the only provider in El Dorado County that can offer 24-hour emergency youth shelter.

The current New Morning Youth & Family Services contract #6372 for emergency shelter care services is due for renewal effective 06/25/2025. The renewal request for this Agreement has a maximum obligation amount which exceeds \$100,000 and will require Board of Supervisor approval.

Services provided by New Morning Youth & Family Services include their 24-hour emergency youth shelter known as the Ashby House Youth Shelter. This is the only 24-hour emergency youth shelter in El Dorado County for homeless and runaway youth that also provides trauma informed care and is licensed by the State of California as a Group Home. This means that New Morning is the only provider in El Dorado County that can offer 24-hour emergency youth shelter.

4. What are the consequences of not purchasing the goods/services or contracting with the proposed supplier?

If we are unable to continue contracting with New Morning Youth & Family Services, children/youth will not have access to 24-hour emergency shelter services. This means that homeless and runaway youth, including foster youth, will not have access to safe shelter, food, care, education, advocacy, and healing that New Morning provides. If children/youth are unable to obtain these services, these children/youth are at a much higher risk to experience further trauma.
