2023-24 ACCOMPLISHMENTS

- Eight meetings in Fiscal Year 2023-24, each providing a **public forum** for discussion of Parks and Recreation concerns and opportunities
- Reviewed and provided feedback to staff on outreach efforts and draft written sections of the **Parks Master Plan update**
- Established and Assembled a **Master Plan Advisory Committee**, composed of recreation providers within and adjacent to the County
- Reviewed and provided input on two new Ordinances: **Bike Park Rules and Dog Park Rules**
- Received presentation from the Coloma Lotus Advisory Committee's subcommittee on recreational uses for the County-owned **Cronan Ranch** property, and provided recommendations to the Board of Supervisors
- Reviewed park needs and recommended items for consideration in the **FY 2024-25 Budget**
- Provided input to staff on the River Management Annual report, 5-Year Summary Report, and **River Management Plan update**

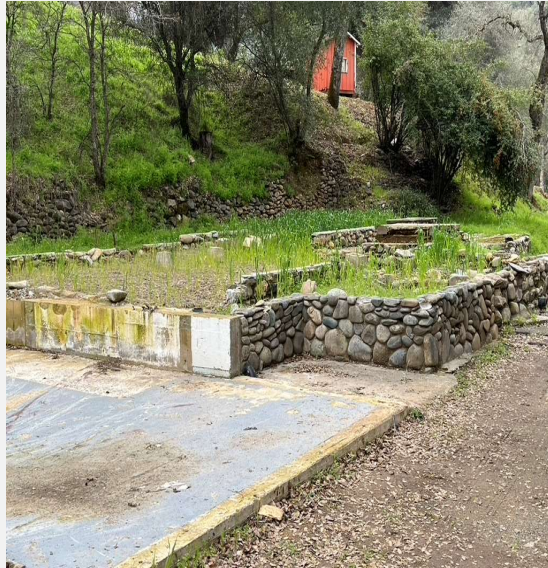
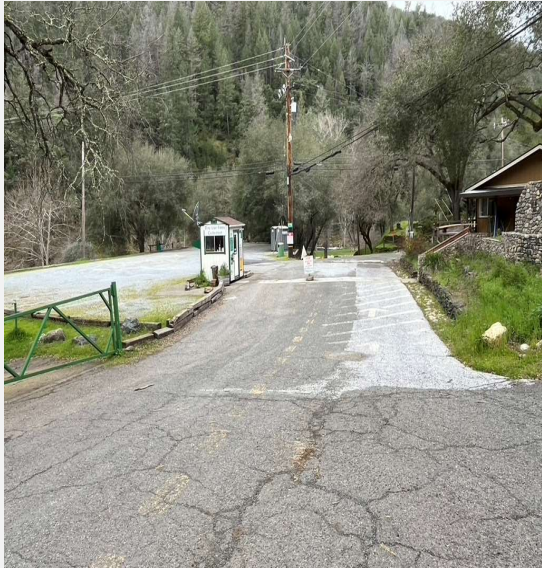

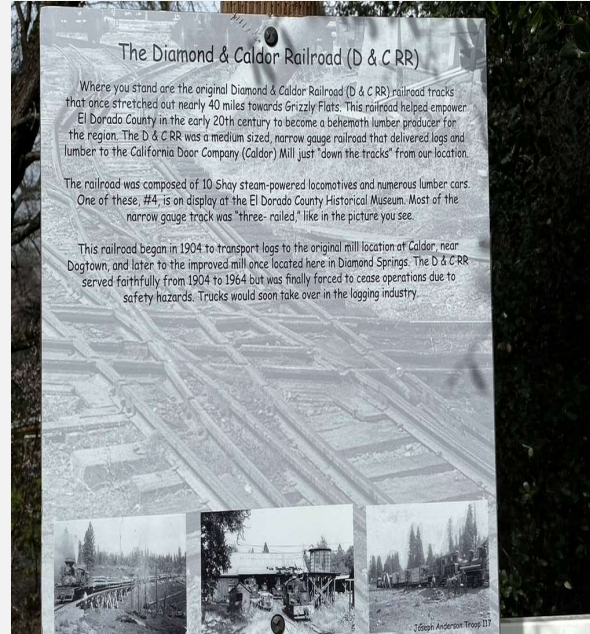

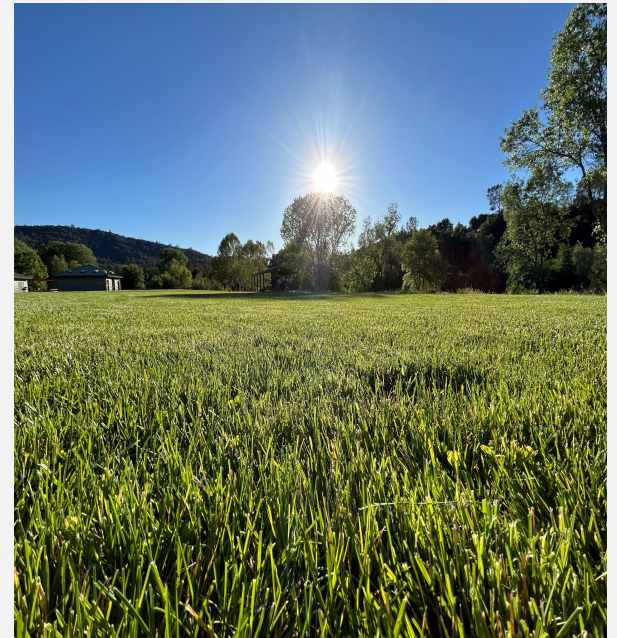

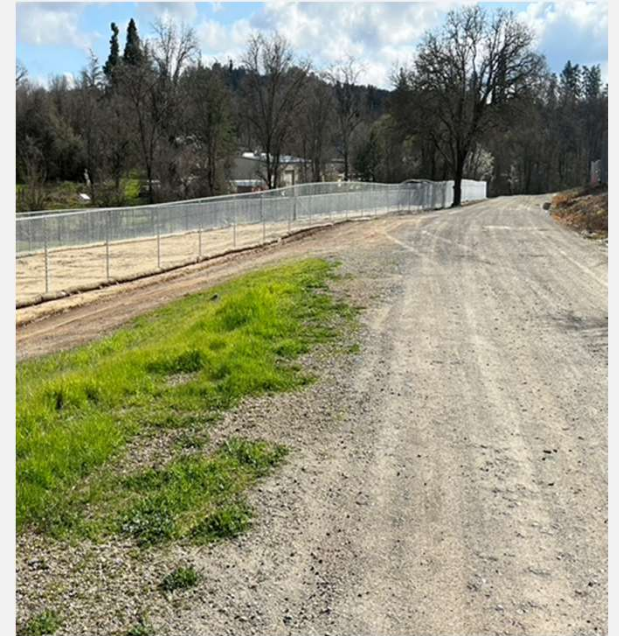

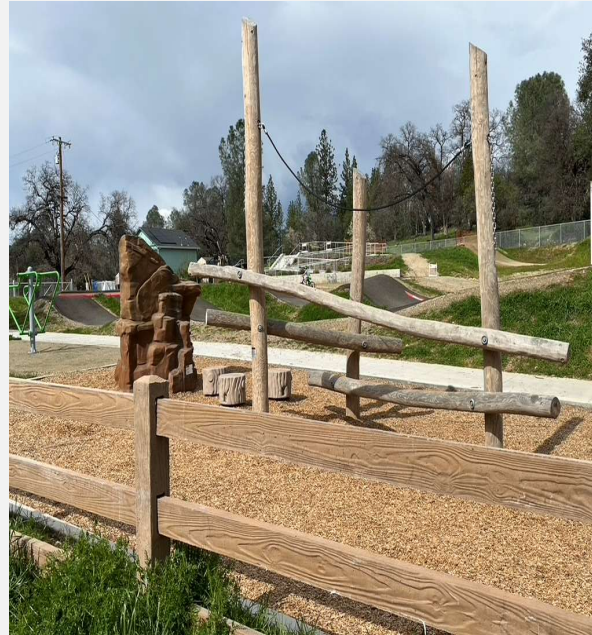

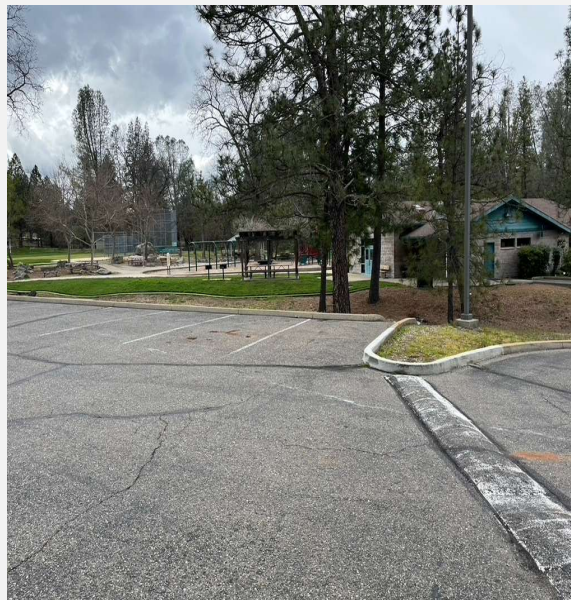

2024-25 GOALS

- Review and provide input to staff and the Board on the Draft **Parks and Trails Master Plan**
- Complete **Historical Railroad Park** dog park & play equipment installation (D-3).
- Re-assemble **Master Plan Advisory Committee** for Master Plan feedback on the complete Draft Parks and Trails Master Plan.
- Provide a public forum for the study of **electric bicycles and scooters** on the El Dorado Trail and develop policy recommendations for the Board.
- Continue to provide a **public forum** for discussion of Parks and Recreation concerns and opportunities
- Aid efforts to develop a park in the community of **Grizzly Flats** (D-2)
- Aid efforts to develop a **30-acre trailhead** in El Dorado Hills (D-1)
- Review and provide input on existing development plans for **Henningsen Lotus Park** and consider timing and funding for specific improvements (D-4)
- Review outcome of Lebeck Engineering study for **Chili Bar** and provide recommendations on priorities and phasing to the Board of Supervisors. (D-4)
- Coordinate with volunteer groups regarding maintenance and improvements to the natural surface **El Dorado Trail** between Diamond Springs and the Sacramento County line, consistent with past practices.
