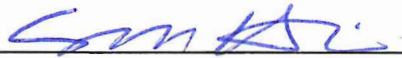

BUDGET TRANSFER JUSTIFICATION AND DESCRIPTION* (will be scanned into FENIX TCM)

The Budget Transfer is for the Countywide Adopted Budget. The Budget Transfer includes the following changes:
 - The budget revisions as outlined in the Adopted Budget Documents presented to the Board on 9/20/22 with Legistar item 22-1668. The changes were attached to the Board item and posted at <https://www.edcgov.us/Government/CAO/Pages/Fiscal-Year-2022-2023-Recommended-Budget.aspx>.
 - Board direction from September 20, 2022. During the review of the Adopted Budget the Board directed the following changes from what was outlined in the Recommended Adopted Budget Documents:
 - Increase Contribution to Non-County Government to EDH Fire for a Rescue Boat in the amount of \$204,000 in the TOT org 1560620
 - Increase Revenue from ToT Special Projects Designation 336 for EDH Fire Boat costs in the amount of \$204,000 in TOT org 1560620
 - Fund Balance adjustments to bring budgeted fund balance in alignment with actual fund balance amounts in each sub fund that are available for use in Fiscal Year 2022-23. These adjustments are included as Exhibit 4 of the Adopted Budget Resolution. With more detail on what each adjust is doing and why.

All accounts are being adjusted once and incorporate all the changes, excluding Board directed changes from 9/20/22. Meaning if a revenue account was added to by \$50 in the Adopted Budget Revisions and a \$10 increase in the Fund Balance adjustments, the budget transfer will reflect one line of \$60 increase. The only changes that will be added as additional lines are the Board directed changes from 9/20/22.
