RESOLUTION ESTABLISHING RULES AND REGULATIONS FOR DOG PARKS

WHEREAS, on April 30, 2024, the Board of Supervisors adopted County Dog Park Ordinance codified in Chapter 9.49 of the El Dorado County Ordinance Code; and

WHEREAS, pursuant to County Ordinance Code Section 9.49.030, use of dog park areas owned or operated by the County of El Dorado (“County”) is subject to rules and regulations as established and adopted by resolution of the Board of Supervisors; and

WHEREAS, once established by resolution, the rules and regulations may be modified by the Board of Supervisors by resolution or ordinance; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of El Dorado that the rules and regulations set forth in Exhibit A – Dog Park Rules and Regulations, attached hereto and incorporated herein by reference, are hereby adopted and shall take effect upon the effective date of Ordinance No. .

EXHIBIT A TO RESOLUTION NO. ____
DOG PARK - RULES AND REGULATIONS

Rules and Prohibited Activities at the Dog Park. Pursuant to El Dorado County Ordinance Code Section 9.49.030, the following rules and regulations shall apply at the dog park:

1. Dogs are not permitted except during established hours of operation. Hours of operation shall be from dawn to dusk.
2. Dogs are not permitted when the dog park is closed as posted for maintenance, due to weather conditions, or special events.
3. Dogs may not be left unattended. Handlers must remain with their dog at all times and keep their dogs under reasonable control as necessary to ensure the safety of others and prevent destruction of property. Handler means an adult person (18 years or older) having custody or control over the dog while at the dog park. Dogs must be placed on a leash while entering and exiting the dog park.
4. Children under the age of six (6) years old are not permitted. Children must be accompanied and supervised closely by an adult and remain within arm's reach at all times.
5. Dogs under the age of four (4) months are not permitted.
6. Dogs that are sick or injured are not permitted. Female dogs in heat are not allowed.
7. All dogs must be neutered or spayed.
8. Each handler is limited to no more than three dogs.
9. Dogs exhibiting unruly, aggressive, or other behavior that jeopardizes human or animal safety are not permitted and must be removed immediately.
10. Any dog(s) which has been declared vicious or potentially dangerous, pursuant to Chapter 6.12.050 of the County Code is not permitted.
11. If a dog injures a person or another dog, handlers must exchange contact information, such as name, address, and any insurance information, and a report filed with the County Parks Division within five (5) days of the incident.
12. Dogs are allowed only in the area designated for their weight class. Large dogs are 30 pounds and over, and small dogs are under 30 pounds.
13. Handlers shall immediately clean up after their dog(s) and properly dispose of waste in the appropriate waste receptacles.
14. The dog park is for use by dogs only. All other activities are prohibited. No animals aside from dogs are permitted.
15. Handlers must prevent or stop their dog(s) from digging and fill any holes.
16. No person shall harass, tease, or incite any dog in any way, including, but not limited to, verbal or physical gestures or throwing of objects other than toss toys.
17. Smoking, including the use of electronic cigarette products, and alcohol are prohibited.
18. No food, treats, or beverages (except water) for dog or human consumption are allowed.

19. No glass containers.
20. No toys (except toss toys, such as balls and frisbees) are allowed.
21. All dogs must be collared, licensed, vaccinated, and wear I.D. tags. Dogs with spiked collars are not allowed.
22. No bicycles, rollerblades, roller skates, skateboards, strollers, and similar items except for wheelchairs and other aids for the disabled.
23. Commercial or professional dog training or classes are not permitted.
