### **Health and Human Services Agency Report and Information Items – July 2025**

#### **Agency Update:**

The consolidation of the two Senior Day Care Clubs into one site, Placerville, took place on June 30th. The El Dorado Hills Senior Day Care site closed on June 30<sup>th</sup>. The Board voted on May 20, 2025 to increase the Senior Day Care fees beginning on July 1, 2025. The new fees will be phased in over a three-year period, with an annual Consumer Price Index (CPI) added beginning in FY 2026 – 2027. Health and Human Services Agency (HHSA) has also ended its participation in the Community Corrections Collaborative (CCC). The two HHSA CCC staff transitioned to Senior Services on July 1<sup>st</sup>. The Senior Nutrition office is now fully staffed as well as the Senior Activities office.

#### **Low-Income Home Energy Assistance Program (LIHEAP)**

The 2025 LIHEAP contract is open and currently serving clients. Applications for the Home Energy Assistance Program (HEAP) and Weatherization services can be submitted via in-person drop-off at the HEAP office during regular business hours, secure drop box at the Placerville HEAP office 24/7, U.S. mail, or online submission at the HEAP website: [www.eldoradocounty.ca.gov/HEAP](http://www.eldoradocounty.ca.gov/HEAP). LIHEAP funding is limited. Applying does not guarantee the applicant will receive funding.

#### **Community Services Block Grant (CSBG)**

The County received the 2025 CSBG contract in January of 2025. The contract is currently 21% expended. We have not heard if additional discretionary funds will be made available.

#### **Senior Nutrition Program**

During the month of May 2025, the Senior Nutrition Program provided 2,966 Congregate (Dine-In Meals) and 11,929 Home Delivered Meals. They also provided 384 meals to the Senior Day Club members. The average donation in May was \$1.91 per meal for congregate and \$0.79 per meal for home-delivered meals. The suggested donation is \$3.00 per meal.

#### **Older Adult Information & Assistance**

- The Family Caregiver Support Program (FCSP) offers respite in-home care services to caregivers who require temporary support to care for themselves. Support groups for caregivers can be found on the El Dorado County Family Caregiver Support Program website (<https://www.eldoradocounty.ca.gov/Services/Assistance-Programs/Seniors/Senior-Services/FCSP>).
- To support transportation services for older adults, Information & Assistance (I&A) will offer Assisted Transportation for Essential Needs, a component of the Friends of Seniors Grant, through June 2026. This transportation service is made possible through the Friends of Seniors Grant, which awarded \$3,000.00 to the Area Agency on Aging to support seniors.
- El Dorado County Fair Outreach, in partnership with Adult Protective Services and IHSS PA, successfully represented the HHSA Older Adult System of Care.

#### **Public Housing Authority/Housing & Homelessness Services**

- The EDOK CoC has established a Homelessness Prevention program that provides flexible funding assistance to people experiencing or at risk of homelessness and/or housing instability who are engaged with a community provider for housing support services.
