

**AMENDMENT NO. 1 TO AGREEMENT**

This AMENDMENT, entered into effective on MARCH 9, 2016, is between the State of California, acting by and through its Department of Transportation, referred to herein as "CALTRANS", and the

County of El Dorado, a political subdivision of the State of California, referred to hereinafter as "COUNTY".

**RECITALS**

1. CALTRANS and COUNTY, collectively referred to herein as PARTNERS, entered into Cooperative Agreement 03-0525 (AGREEMENT) dated on May 7, 2013.
2. AGREEMENT outlined the terms and conditions for the Project Approval and Environmental Document (PA&ED), Plans, Specifications, and Estimate (PS&E), Right of Way (R/W) and Construction components of the improvement project between Pleasant Valley Road and Diamond Springs Parkway on State Route 49, referred to hereinafter as "PROJECT".
3. Since execution of AGREEMENT, PARTNERS have agreed to enter into Amendment No. 1 to AGREEMENT (AMENDMENT) in order to add CALTRANS as a funding partner. CALTRANS will contribute \$1,000,000 in SHOPP Minor funds towards construction capital costs.
4. A revised funding summary is attached and made part of this Amendment.

**IT IS THEREFORE MUTUALLY AGREED:**



6. CALTRANS will invoice COUNTY for the actual cost of any SFM as a CONSTRUCTION CAPITAL cost.

After PARTNERS agree that all WORK is complete, CALTRANS will submit a final accounting for all SFM costs. Based on the final accounting, PARTNERS will refund or invoice as necessary in order to satisfy the financial commitments of this Agreement.

7. COUNTY is the IMPLEMENTING AGENCY for CONSTRUCTION CAPITAL as described in the Responsibilities section of this Agreement.

Therefore, based on the funding types displayed in the FUNDING SUMMARY table for this PROJECT COMPONENT:

- COUNTY will submit monthly invoices to CALTRANS for CALTRANS' actual share of costs.
- CALTRANS will pay invoices within forty-five (45) calendar days of receipt.

After PARTNERS agree that all WORK is complete, COUNTY will submit a final accounting for expenditures paid by CALTRANS. Based on the final accounting, PARTNERS will refund or invoice as necessary in order to satisfy the financial commitments of this Agreement.


