AGREEMENT FOR SERVICES #2653 AMENDMENT I

This Amendment I to that Agreement for Services #2653, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and On My Own Independent Living Services, a California corporation, duly qualified to conduct business in the State of California, whose principal place of business is 6939 Sunrise Blvd, Suite 215, Citrus Heights, CA 95610; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide Empowered Parenting Program, a one-to-one skill building training and parenting program, and Independent Living Services, a one-to-one skill building training, on an "as requested" basis for adults with developmental disabilities referred by the County of El Dorado Health and Human Services Agency, in accordance with Agreement for Services #2653, dated June 25, 2018, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the maximum obligation to \$120,000.00 and extend the term by one (1) year of said Agreement, hereby amending ARTICLE II Term and ARTICLE IV Maximum Obligation; and

WHEREAS, the parties hereto have mutually agreed to add **ARTICLE XXXIII Counterparts**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #2653 shall be amended a first time as follows:

Articles II, and IV are amended in their entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective when fully executed by all parties hereto and shall terminate on May 31, 2022, unless terminated earlier pursuant to the provisions contained herein this Agreement under the Article(s) titled "Default, Termination, and Cancellation" or "Fiscal Considerations."

ARTICLE IV

Maximum Obligation: Total amount of this Agreement shall not exceed \$120,000.


Article XXXIII is added and reads as follows:


Except as herein amended, all other parts and sections of that Agreement #2653 shall remain unchanged and in full force and effect.
