Hell John,

As a multi decade homeowner living in EDH, I'm writing to voice my OPPOSITION/DISAAPPROVAL to the project that designates the CEDHSP area as Sacramento Area Council of Governments (SACOG) "Green Zone." SACOG Green Zones are meant for infill development. Generally, infill is development such as the apartments at Town Center--that is, development of small parcels with infrastructure already in place.

However, Parker Development and El Dorado County staff have consistently referred to the proposed Central El Dorado Hills Specific Plan (the old golf course and the Pedregal Planning Area) as infill. Now the Department of Transportation is attempting to have it officially labeled as an infill Green Zone.

The General Plan states that infill sites "may not be more than five acres in size and must demonstrate substantial development has occurred on 2 or more sides of the site." (Policy 2.4.1.5)

Besides providing no documentation as to why the CEDHSP should be included as part of a designated Green Zone, the fact is that it doesn't even qualify given the definition of infill as found in the El Dorado County General Plan.

I'm urging you and your fellow BOS elected officials to vote NO on the proposal for reclassification of the CEDHSP as SACOG "Green Zone". Please drive this message home and discourage the BOS from approving such destructive and vehemently opposed action plan in EDH...

We are learning that you are considering entering into an agreement with COSOG regarding green zones. Approving this resolution may sound enticing but will ultimately result in you losing your planning control of any COSOG development participation in order to gain their financial participation in those projects. I urge you to table this matter until you fully understand what you need to give up and the impacts to our residents before you agree to work with them. You need to read the fine print and find out what COSOG will require of you. Will you have total project control and veto power? No, you won't.

Beyond loss of local control, residents in El Dorado Hills and especially those living in and around Blackstone are very concerned about the massive amount of development taking place and being proposed on Latrobe road. Residents are beginning to feel discarded and unheard. I do not think the County makes a good effort to communicate with us or to listen when you do.

We are barely assimilating the Carson Creek settlement and now are hearing about a 50 acre sports complex and housing development. Whether it be the need for low income housing, expansion of EID facilities or the desire for sports fields etc...we always seem to get the short end of the stick. We have a rural County and we want to keep it that way. That's why we live here. We don't want to be an extension of Sacramento or Folsom.

I urge you to reject this COSOG Resolution. Let's make our own development decisions and please let us be a part of those decisions. Please remember that we are part of the County and please reject any participation with COSOG.

Now, high density housing is being added to the Town Center, many new developments have sprung up along White Rock and Old Placerville Rd, the area is already becoming congested, and the county is now proposing to approve even more high-density housing. The business park should remain a business park, encouraging new businesses to make their homes here, increasing the tax base of El Dorado County in a way that doesn't take away from the beauty and charm of our community.

El Dorado County has already required that new residential communities adopt water-wise landscapes, which we've done with the understanding that the county wants to conserve our natural resources. However, adding more high-density housing will greatly impact the goals the county has. In addition, our streets and highway will become congested and, I believe, the value of homes purchased in the last year will see a decrease in value because El Dorado Hills will not be as desirable an area to live in as it is now. The walking trails surrounding Heritage El Dorado Hills will become more well-travelled and will need to be kept up. As a resident of the Blackstone Community and, more importantly El Dorado County, I strongly believe that relinquishing any portion of the County of El Dorado's ability and responsibility to control these types of decisions solely in the best interest of the residents of the County will result as a long-term detriment to El Dorado Hills and El Dorado County.

As a teenager and a young adult, I remember fondly the peace, quiet, beauty, and enjoyment of living in a rural environment. When my wife and I started our family, I wanted to provide that experience to my children while still being in a location close to our work in Downtown Sacramento. This is one reason why we chose to move to the Blackstone community in El Dorado Hills. As a dark sky community, we can sit in our backyard, enjoy the peace and quiet of the community while viewing the stars at night. The facilities that come with the SACOG Green Means Go Resolution, such as a lighted sports park, light rail transit system, and increased density developments, will diminish this experience for my son and my family.

In addition to this, as previous residents of Fair Oaks, where we moved from, and long time visitors of the City of Folsom, we have seen first hand the degradation of these communities due to the expansion of light rail into them with increased homeless encampments, panhandling, crime along with degradation of the parks and open space areas. This is another reason why we chose to move into El Dorado Hills rather than Folsom.

Again, I urge you to please vote against the SACOG Green Means Go Resolution, Agenda Item #20, Resolution 027-2021, at the Board of Supervisors meeting on April 13, 2021.

**WHEREAS**, El Dorado County is a member of the Sacramento Area Council of Governments (SACOG); and

**WHEREAS**, the region faces an ambitious state-mandated per capita greenhouse gas reduction target of 19 percent by 2035 for the Metropolitan Transportation Plan/Sustainable Community Strategy (MTP/SCS), adopted November 18, 2019; and

**WHEREAS**, El Dorado County is committed to helping the Sacramento region meet its 19 percent greenhouse gas reduction target by facilitating more housing and transportation choices and advancing economic prosperity; and

**WHEREAS**, SACOG and its member local governments must work in partnership with the state in order to support housing and transportation projects that will help the region and the state achieve our environmental goals; and

**WHEREAS**, The Green Means Go pilot project will be a meaningful and measurable effort to catalyze and advance projects and programs that accelerate infill housing, travel options, and electric vehicle deployment in targeted areas, called Green Zones; and

**WHEREAS**, SACOG has solicited its member local governments to nominate Green Zones that are 1) within infill areas, defined by the 2020 MTP/SCE Community type map as Center and Corridor communities or Established Communities; 2) within areas planned for growth or being considered for increased growth through current local planning work; and; 3) supported by local policies and actions that support increased development or redevelopment in the area; and

**WHEREAS**, SACOG acknowledges that Green Zones are areas where new growth is planned or being planned, and encourages, where applicable, outreach in disadvantaged communities, proactive anti-displacement policies, and mitigation strategies in an attempt to reduce gentrification and displacement within Green Zones as they grow and transform; and

**WHEREAS**, SACOG understands that funding and priorities can change over time and will allow amendments to the Green Zones on an as-needed basis following discussions with local agency staff and at the discretion of the SACOG Executive Director; and

**WHEREAS**, SACOG has reviewed nominated Green Zones within El Dorado County and has accepted those nominations as having met the Green Means Go Zone eligibility requirements.

### **THEREFORE, BE IT HEREBY RESOLVED,**

1. The Board of Supervisors is committed to helping the State of California and the SACOG region reach its current 19 percent greenhouse gas reduction goal through implementation of the Green Means Go pilot project.

2. Designates the following named areas as Green Zones:

- Green Zone #1: El Dorado Hills
- Green Zone #2: Cameron Park
- Green Zone #3: Diamond Springs

3. Authorizes the Director of Transportation or designee to propose amendments to Green Zones designated above to the SACOG Executive Director for Green Zones and of all other documentation necessary to participate in the Green Means Go pilot project.

### DISCUSSION / BACKGROUND

Our region faces an ambitious state-mandated per capita greenhouse gas reduction target of 19 percent by 2035 per the Metropolitan Transportation Plan/Sustainable Communities Strategy, which was adopted on by the Sacramento Area Council of Governments (SACOG) on November 18, 2019. SACOG and local governments must work in partnership with the State to support new and innovative housing and transportation projects that will help the region and the state achieve climate goals.

Green Means Go is a multi-year pilot program created by SACOG to lower greenhouse gas (GHG) emissions in the six-county Sacramento region, as required under the Sustainable Communities and Climate Protection Act of 2008, also known as Senate Bill (SB) 375. The pilot program focuses on three key emission reduction strategies which include accelerating infill development, reducing vehicle trips, and promoting clean mobility options, in targeted areas, called Green Zones. For Green Means Go to be most effective, Green Zones need to be in areas where new growth is planned and is supported by local policies and actions so that the efforts to accelerate infill, travel choice, and electrification all have potential to be complementary strategies.

Green Zones will be areas within El Dorado County where qualifying development or redevelopment projects will be eligible for funding should SACOG receive state funding leading up to the next Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS) update.

The framework for establishing a Green Zone is centered around a locally led collaborative nomination process which was approved by the SACOG Board of Directors on August 20, 2020. Qualifying areas within El Dorado County were subsequently identified, and nominated by County Staff to be designated Green Zones under the Green Means Go pilot program (Attachment A). The Board of SACOG approved the zones that were nominated by County Staff on December 17, 2020. They include:

Green Zone #1: El Dorado Hills

El Dorado Hills is located in an established Community Region identified in the SACOG MTP/SCS. The Jobs/Housing Balance in 2018 was 0.9 jobs to every house in El Dorado Hills. More than 50% of the workforce in the El Dorado Hills Business Park commutes into El Dorado Hills from other parts of the region. The El Dorado County Transportation Commission (EDCTC) is currently studying various land use scenarios to redevelop parts of the Business Park through the El Dorado Hills Business Park Transportation Plan.

Potential Funding from SACOG through the Green Means Go pilot program could fund housing, transit improvements, broadband, electric vehicle infrastructure, bicycle/pedestrian improvements and electric bike share programs.

Green Zone #2: Cameron Park

Cameron Park is located in an established Community Region identified by the SACOG MTP/SCS adjacent to U.S. Highway 50. A portion of Cameron Park is also identified as a Low Income Area by the SACOG MTP/SCS. These are areas where 40% or more of the people live at 200% or less of the federal poverty level. The Jobs/Housing Balance in 2018 was 0.4 jobs to every house in Cameron Park. Similar to many areas in El Dorado County, this indicates that residents commute outside of the area to work. There are 320 acres with over 129 parcels available for commercial or industrial development in Cameron Park. Such development would bring jobs closer to this well-populated area.

Potential Funding from SACOG through the Green Means Go pilot program could fund transit improvements, broadband, electric vehicle infrastructure, and bicycle/pedestrian improvements.

Green Zone #3: Diamond Springs

Diamond Springs is an Established Community Region as identified by the SACOG MTP/SCS. Diamond Springs is located adjacent to State Route 49. Most of Diamond Springs is identified as a Low Income Area by the SACOG MTP/SCS and a disadvantaged community in accordance with the Active Transportation Plan (ATP) definition. These are areas where 40% or more of the people live at 200% or less of the federal poverty level. Significant portions, roughly 20% of residents, are either elderly or disabled.

Potential Funding from SACOG through the Green Means Go pilot program could fund road improvements, transit improvements, Travel Demand Management (TDM) Programs, planning, electric vehicle infrastructure, bicycle/pedestrian improvements and off-street parking.

Each Green Zone is shown on the attached Green Means Go Green Zones Nomination Map (Attachment B). The Board is being asked to adopt a resolution (Attachment C) that would approve these designated Green Zones in El Dorado County, and thereby make projects within that zone potentially eligible for state funding under the Green Means Go pilot program. There is currently no



state funding for the Green Means Go pilot program. However, Assembly Bill 1209, introduced by Assembly Member McCarthy on February 19, 2021, would, if enacted, codify the Green Means Go Grant and Loan Program.

The resolution will also authorize the Director of Transportation or designee to propose amendments for the Green Zones and all other documentation necessary to participate in the Green Means Go pilot program.

**ALTERNATIVES**

The Board could direct staff to choose alternative zones that meet the SACOG criteria for nomination which would then need to be approved by the SACOG Board, or the Board could choose not to designate Green Zones in El Dorado County and the County would not be eligible for related Green Means Go pilot program funding opportunities.

I am writing to you to voice my opposition to the planned resolution (Agenda item #20 [Resolution 027-2021]) related to the Sacramento Area Council of Governments which appears to give that organization the ability to plan and develop various levels of income-related housing and mass transit projects within the area in which I reside.

As a resident of the Blackstone Community and, more importantly El Dorado County, I strongly believe that relinquishing any portion of the County of El Dorado's ability and responsibility to control these types of decisions solely in the best interest of the residents of the County will result as a long-term detriment to El Dorado Hills and El Dorado County.

Over the past 3-5 years, it appears to me that the overall planning for development of the El Dorado Hills area has been extremely piecemeal with one project after another making rezoning changes from zoning set out in the El Dorado Hills General Plan. Continual addition of one residential development after another appears to have been done without much (or any) consideration to the overall impacts, both negative and positive, from this approach.
