The County of El Dorado Board of Supervisors held a public hearing on Tuesday, August 19, 2025, at 3:00 p.m., to update hourly rate and fees for services collected by the Planning and Building Department. This amendment will increase and/ or decrease the billing rates and set the new fee for charges for services based on the revised billing rates. This Ordinance shall take effect sixty (60) days from final passage, with the exception of the Code Enforcement Division and Vacation/Hosted Rental Unit, shallbecomeeffectivethirty(30)days from passage
