The Health and Human Services Agency (HHSA), Animal Services Department (ASD), is requesting a budget transfer increasing appropriations in the amount of \$236,000, increasing revenue in the amount of \$147,000, and increasing budgeted Net County Cost in the amount of \$89,000. The increase in Net County Cost is offset with a reduction of the budgeted General Fund Contribution to Community Services, Area Agency on Aging (AAA) Program, due to savings resulting from staffing vacancies. Budget transfer details as follows: 1) To increase Mutual Aid to be paid to various jurisdictions for their assistance with the Caldor Fire in the amount of \$196,000, 75% of which is being offset by FEMA reimbursements in the amount of \$147,000. Net County Cost increase \$49,000 2) To increase the transfer of Indirect Cost Rate (ICR) charges from Animal Services to Admin/Finance in the amount of \$40,000 due to Board approved compensation changes that were effective in FY 21/22. Net County Cost increase of \$40,000 3) To shift General Fund savings from Community Services (CS), AAA Program, to Animal Services in the amount of \$89,000 to offset the Net County Cost increase. Savings in CS are a result from continued staffing vacancies. 4) To increase Op Tsfrs from Animal Services to the ACO Fund for the contract to remove the old kennels and install the new ones in the SLT facility in the amount of \$35K, offset with savings in appropriations for Special Department Expenses. No impact to Net County Cost. The net results in zero impact to County General Fund.
