RESOLUTION NO. 213-90

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION FOR LOTUS PARK FEES

WHEREAS, Lotus Park will need revenue for operation and maintenance support from users; and

WHEREAS, there is limited space for public use of the parking area, El Dorado County permitted commercial rafting companies are hereby limited to "loading and unloading vehicles", and may not use Lotus Park under the "Park Day Use Fees" schedule.

WHEREAS, these users and uses differ, the following shall be the fee schedule for day use:

PARK DAY USE FEES:

Bus (Commercial or Private) 30 passengers or more	\$30.00
Mini Bus or Van (Commercial or Private) 15-29 passengers	15.00
Mini Bus or Van (Commercial or Private) 6-14 passengers	10.00
Private Vehicle	3.00

Private Vehicle (County Resident) 12.00 for annual pass

RIVER PUT-IN AND TAKE-OUT FEES:

Commercial Rafts or Boats	6.00
Commercial Kayaks or Other Craft	2.00
Private Rafts or Boats	3.00
Private Kayaks or Other Craft	1.00

EXCEPTIONS TO THE ABOVE SCHEDULE ARE:

- (1) Loading and unloading vehicles
(Commercial or Private), 15 minute
parking limit NO CHARGE
- (2) Non-motorized (walk-ins and bicycles) NO CHARGE
- (3) El Dorado County Schools
Grades K-12 (**RESERVATION REQUIRED**) NO CHARGE
