DEPARTMENT/SUPERVISOR UPDATES

Robyn Drivon, County Counsel, wanted to update the Board on the assignment she undertook to review the medical marijuana ordinance. The initial meeting will be scheduled for later this month or early February. The meeting notice will be posted on the El Dorado County web site and she will announce it at a Board meeting. The meeting will be open to all and will have an open forum format.

Dave Johnston, Air Quality Management District, gave an update on the chimney smoke reduction incentive program. In 2014, they did forty-one (41) stove replacements in South Lake Tahoe and seventy-six (76) in the West Slope. This saves each resident approximately \$200/year in home heating costs and also improves the air quality by approximately one-hundred pounds of emission per stove per year. This improves the clarity of Lake Tahoe by preventing those emissions from landing on the surface of the lake.

Supervisor Mikulaco attended the Capital Southeast Connector Joint Power Authority meeting last week. There was a workshop which centered around financing the project.

Supervisor Frentzen reported that there was a budget ad hoc committee meeting yesterday. The policies for the County were discussed regarding reserves and fund balance. They are looking to other counties as examples. They are working on a draft version of those policies. They also discussed what are the priorities and what is the purpose of the County for providing services.

Supervisor Novasel attended the First Five meeting yesterday. The County Health Department spoke about services and costs. Long term goals were also discussed.

Supervisor Ranalli reported that he had his first town hall meeting.

Supervisor Veerkamp reported that he and a committee have been working on the homelessness project in conjunction with the city. The County does not have any ordinances to deal with illegal camping, extreme vagrancy or panhandling. The committee is recommending that the County pursue the ordinances so there is consistency.

Supervisor Veerkamp wants to empower staff to review all committees and commissions for relevancy and accuracy with Board input.

Supervisor Veerkamp attended Main Street Matters in Placerville last Wednesday night. Their project is to repave Main Street and do some beautification. The next meeting is in February.

Next Tuesday, January 20th, at Oak Ridge High School the high school district is looking at a boundary line workshop because of the discussions surrounding increasing Oak Ridge's capacity to 102%. This could impact the other high schools in the County.
