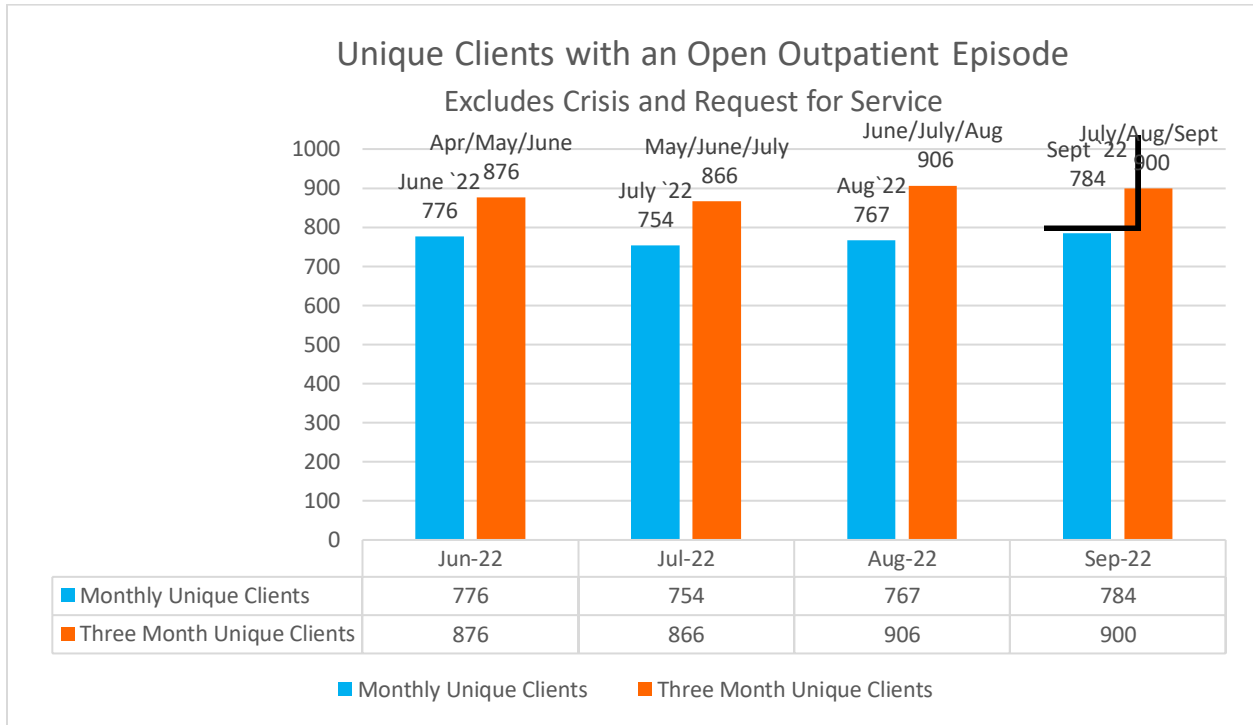
**BH Director & DEPUTY DIRECTOR UPDATES

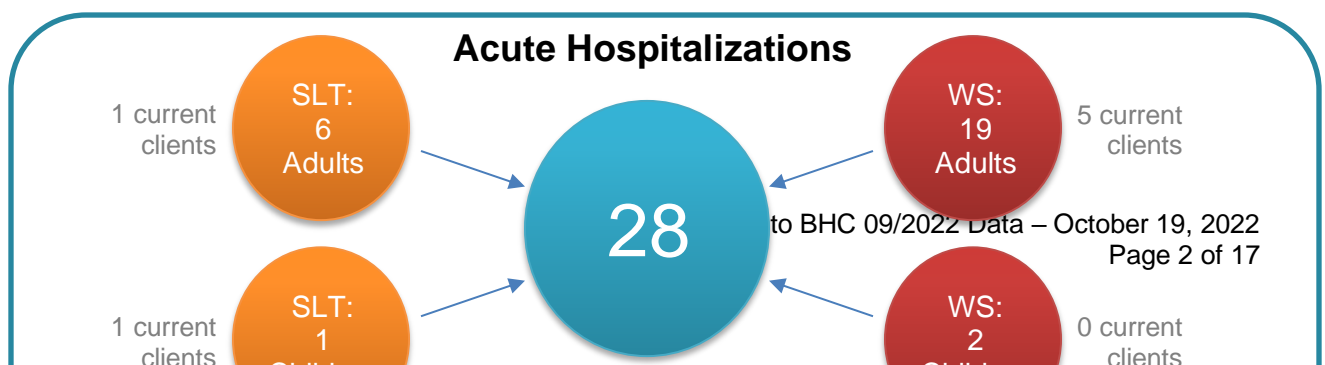

West Slope:

- 4 clients graduated from the T house program in August and September.
- 3 clients were able to secure an apartment and one client found a job with live in benefits.
- We are in the process of graduating 4 more clients by next month.
- In the month of September, we had 3 new clients move in the T house 2 of which were exited due to substance use and not agreeable to SUDS services but continue to receive FSP services while living in the community.
- 1 client out of the 3 that moved in remains and is doing great in the program.
- Although the number for the past few months are similar regarding open beds there has been movement as far as clients moving on to Independent Living and new clients moving in.
- We have several upcoming interviews for T house placements and continue to work with the PHF to assess clients for T house appropriateness and placement.
- During the months April through September the number of occupants in the T house is generally less as the weather is warmer and suitable for those to live homeless. During the months of October through March the referrals and request for T house placements increase as the weather becomes cold and unmanageable to live in.
- We are working with the LPS team to step several clients down from high levels of care into the T houses within the next few months.

West Slope

South Lake Tahoe

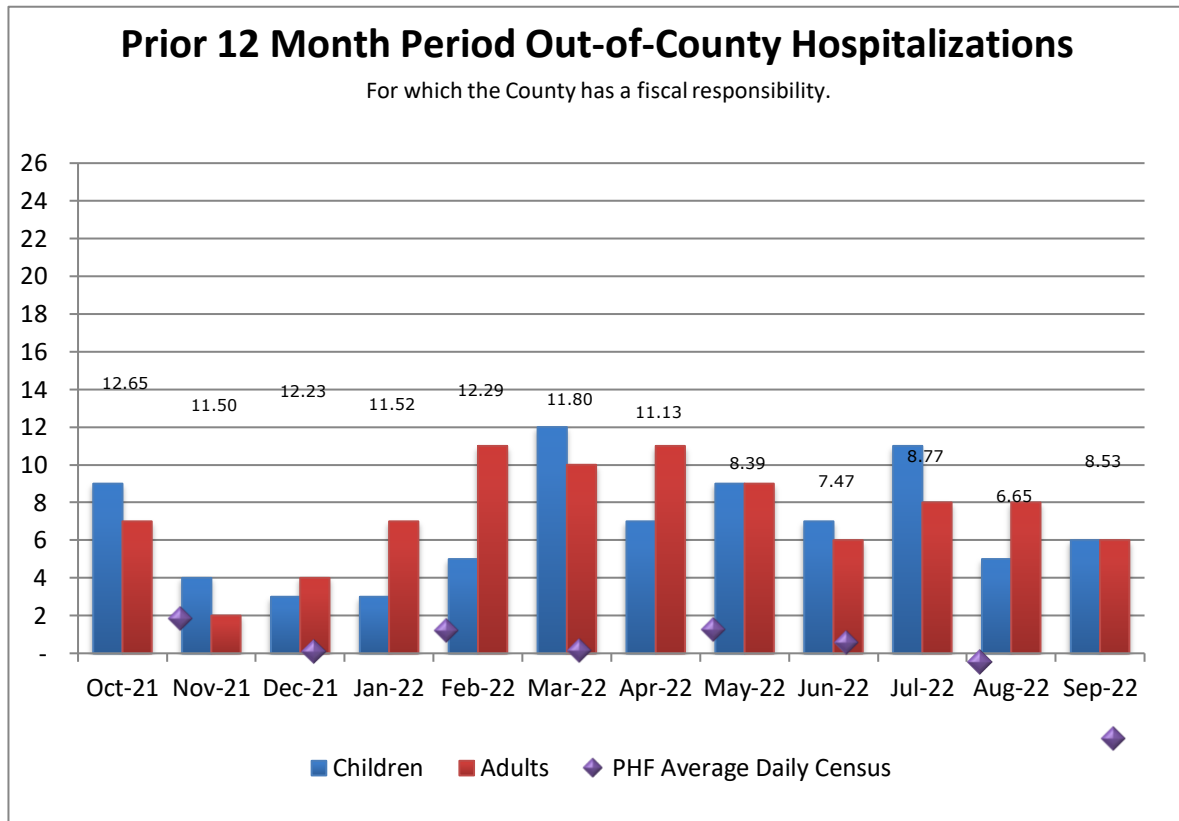
Clients receive ICM team coverage

 - This development is a floating unit configuration based on household size rather than a specific number of apartments for each number of bedrooms

Psychiatric Health Facility (Lesly Van Sloten)

- There were **25** Admissions; **17** Admissions were El Dorado County residents and **8** were Out of County residents.
- There were **16** El Dorado County residents discharged; **8** to Home with Support, **0** to Home without support, **0** MHRC/IMD, **1** Board and Care, **0** to ICM T-House, **0** to Shelter, **7** to Other, and **0** to Emergency Department.
- Upon discharge, **15** El Dorado County residents were insured and **1** El Dorado County residents were pending insurance.
- There were **5** Seclusion Episodes, **5** Physical Restraint Episodes (**1** minutes), **3** Assaults, **1** Elopement, **0** Medication Errors, Client Surveys **23**
- There were **3** denials of El Dorado County referrals: Medical complications, Methadone, CPAP
- Average daily census was **8.53** (range **6 - 12**) with **6.48** average length of stay of days.
- Concurrent Reviews resulting in no medical necessity found. **0**

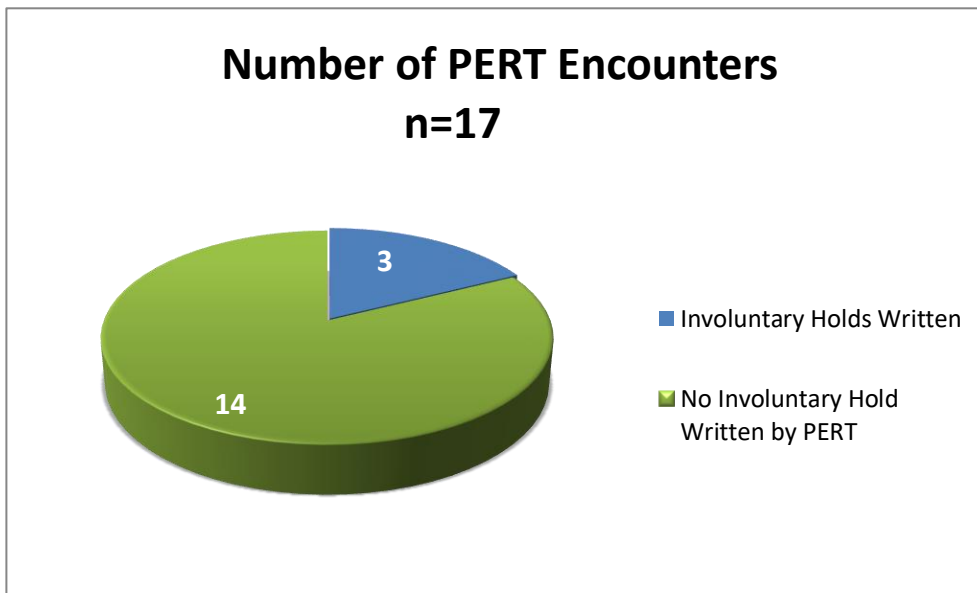
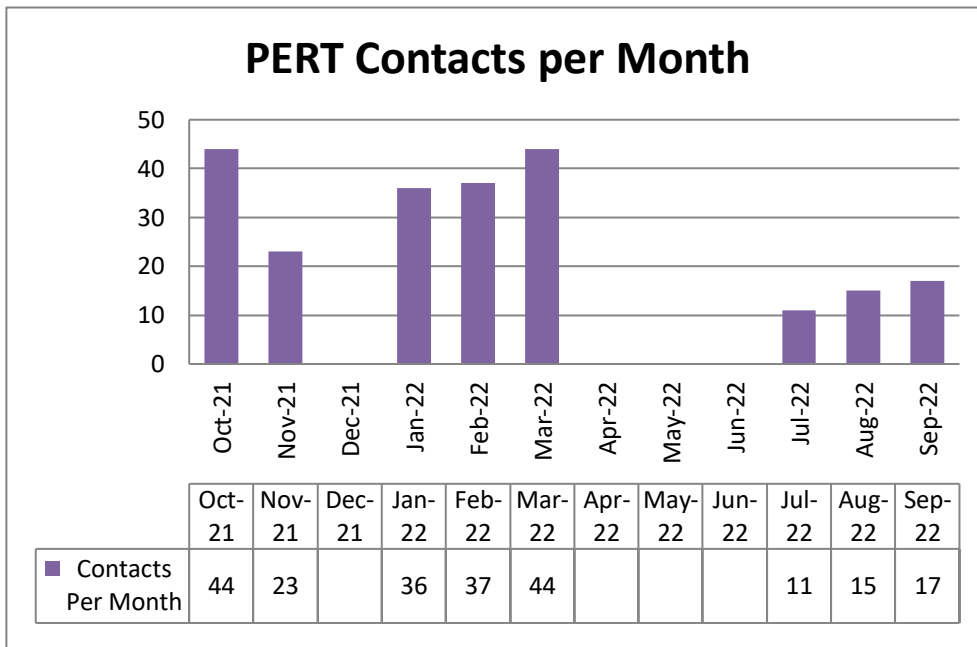
Crisis Intervention Teams (CIT)

- **SLT:** No formal meeting is being held at this time.
 - In SLT, we are able to provide PES to the community with the help of our existing staff (program manager, program coordinator and 1 MH clinician).
 - To address the gap in coverage due to staffing shortage, we are utilizing Locum Tenens psychologists.
- **WS:** Monthly CIT meeting was held March 3rd. The meeting was well attended by EDSO, Jail, Justice services, APS, EDC BH and Public Guardian.

Psychiatric Emergency Response Team (PERT) (Angelina Larrigan)

PERT services were minimal the month of September due to the Mosquito fire support needs. PERT worked 14 days in September.

South Lake Tahoe Alternative Collaboration Services (STACS) (Chris Kernes)

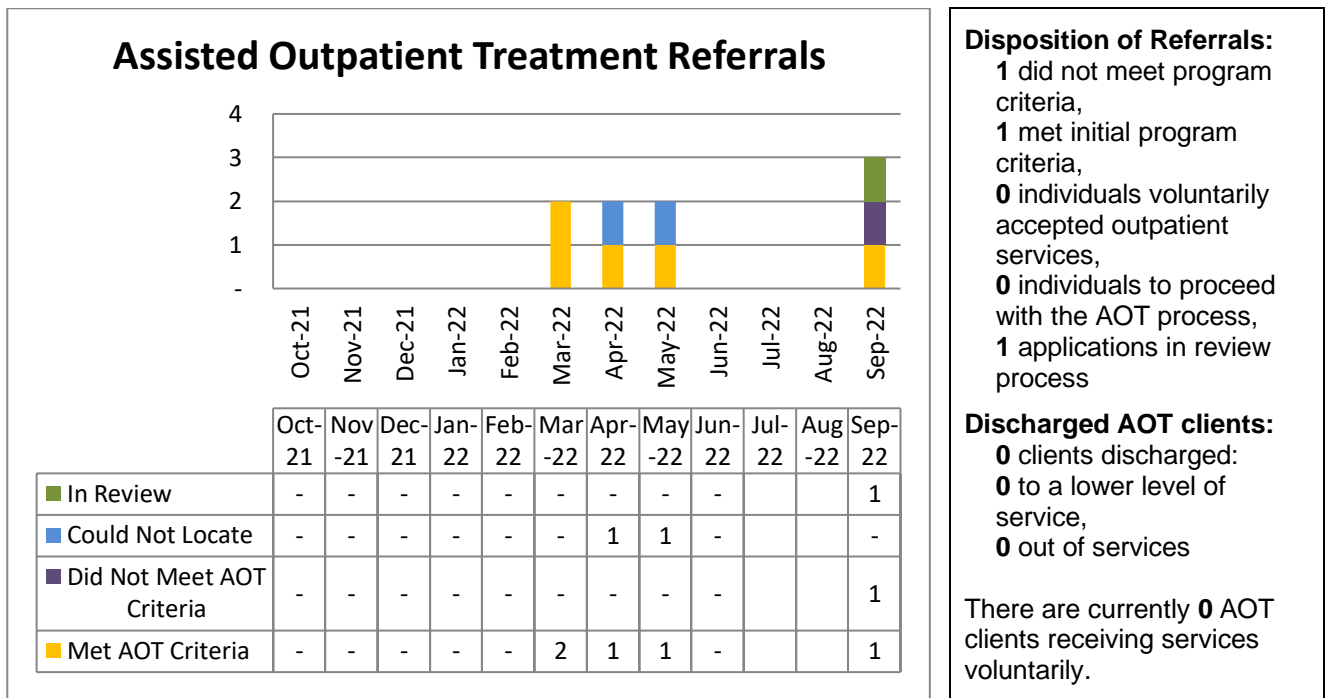
- Formal STACS meetings have been put on hold; however, each participating STACS community member continues to communicate and collaborate as needed and appropriate.

QUALITY ASSURANCE & PATIENT RIGHTS

Quality Improvement / Utilization Review (Ren Strong / Krystal Hogan)

- As indicated in last month's report, the Triennial System Review Audit was conducted virtually on 9/13 and 9/14 with DHCS staff and the QA team and key EDC BH personnel as well as staff from IDEA Consulting. The focus of the two-day review was on the adequacy of the documentation submitted to DHCS in August. During this review, DHCS requested additional documents be submitted within 5 days to help support achieving system compliance. We would like to thank everyone who was involved in both the system review and the subsequent efforts in gathering the additional requested documents. DHCS will provide a Findings Report which will indicate our level of compliance for each category outlined in the System Review Protocol as well as the steps required to achieve compliance in any deficient areas. CalAIM is a large reform with multiple implementation dates that we continue to meet internally about; we created a CalAIM Team Meeting involving other programs such as Fiscal, IT, and SUDS. We are beginning to discuss the Documentation Reform changes that will come in July, and strategies to see how we can ensure we are in compliance.
- During the on-site review, DHCS also requested some additional documentation for the Chart Documentation Review which were gathered and submitted to DHCS. The on-site Chart Review with DHCS will be conducted virtually on 10/12 and 10/13.

- Behavioral Health Quality Improvement Program (BHQIP) is another major undertaking that QA/UR staff and staff from other divisions have been working on. BHQIP is a program with the goal of helping us with the implementation of the CalAIM initiative. BHQIP has outlined deliverables to be produced and the milestones and deadlines for the submission of those deliverables. If these milestones and deadlines are met, participating programs are entitled to incentive payments from the State once DHCS confirms that the submissions are CalAIM compliant. The first deadline for deliverables was 9/30/2022. Prior to that deadline, DHCS released a notice which extended deadlines for many of the milestones until 3/1/2023. Three of the milestone deadlines were not extended and thanks to the hard work of many staff from several divisions, those deliverables were submitted by the 9/30 deadline.
- 274 Provider Network Data Reporting Update: QA/UR and our IT staff continue to make progress with this endeavor and are working hard to overcome the various challenges that we are presented with. We are currently waiting for communication from DHCS re their receipt and review of our submission so that we may proceed. We are already working on Phase 3 with our IT as well as with the assistance of the county's Central IT to develop a data import tool that will greatly streamline importing all of the required information into our EHR. This process will save us a lot of time and we are grateful to Central IT for their contribution.

PROGRAM ACTIVITY UPDATES

SUBSTANCE USE DISORDER SERVICES (Salina Drennan)

- Quality Assurance Supervisor and Manager focused work on CalAIM deliverables due by 9/30/2022. This included updates to and creation of training plans and new policies. In addition, staff has been working with contract providers to provide CalAIM training to each provider in the network. SUDS leadership will continue to work on aligning our system with CalAIM requirements in order to meet future deadlines for DHCS.

MENTAL HEALTH SERVICES ACT (MHSA) (Meredith Zanardi/Moriah Weldy)

- Held meetings with contract providers and community partners as part of initial Community Program Planning Process (CPPP)
- Participated in various conference calls, webinars, and meetings related to items of interest to MHSA.
- Began scheduling CPPP meetings hosted by providers to utilize their existing community networks and identified three dates for meetings hosted by our MHSA Team

SUICIDE PREVENTION (Meredith Zanardi / Nicole Ebrahimi-Nuyken)

ADULT OUTPATIENT SERVICES

(Jody Kwachak-Hall (SLT); Doris Jones (WS))

Tahoe:

- The SLT Outpatient Clinicians and Mental Health Workers actively work with Clients to provide MH services in the office, in Clients' homes, by telephone and by telehealth. The Clinicians and Mental Health Workers provide services in community settings. Any face-to-face meetings are conducted with safety as a priority, ensuring that COVID precautions and current guidelines are adhered to.

SLT has 4.5 Clinicians, and 4 FT, and 2 PT Mental Health Workers providing services to 137 outpatient Clients.

West Slope:

- Adult Outpatient Clinicians are actively working with Clients to maintain their stability in the community, keep them from needing a higher level of care and working with them to reduce incarceration. They also run billable groups through the Wellness Center. Due to low staffing levels, FSP Clinicians have taken on Adult Outpatient Clients, and they seem to enjoy working with less complex care needs clients. This collaboration is also helping to reduce burn-out from FSP Clinicians. To assist our collaborative partners at probation, one half-time TAY Clinician and two Mental Health Workers have been assisting the BH/SUD Program at the CCC by providing clinical care, assessments and two groups a week, on a temporary basis, until that full-time position is filled.

Wellness Center Activities:

Tahoe:

- Wellness is open four days per week providing groups to enhance Clients' lives (games, snacks, outings, art, independent living skills, symptom management and skills educational groups, and more). This month's Wellness program included a Nature Trail Walk, Yoga, Pickle Ball, and field trips to Carson City and a Reno Aces Baseball game.

West Slope:

- Wellness is open four days a week providing groups and activities to promote socialization, independent living skills, psychoeducation, and symptom management. Client come to the Wellness Center and participate in cooking group which they serve the food to their peers. Clients are loving the Art group facilitated by a former client. Clients are diving into the garden group. Peer leaders are volunteering in the Wellness Center gaining job skills and working on their socialization skills. We are bringing back fun Fridays in the Wellness Center which include Karaoke, Bingo, and client game day. We placed a jar for client ideas for Fun Friday as well. Clients are helping plan for holiday events at the Wellness Center.

ICM Activities:

Tahoe:

- Outings to: Carson City, Reno Aces game, Nature Trail Walk, Exercise activities: Yoga, Pickle Ball, Behavioral Health skills groups, and Expressive Arts through painting.

West Slope:

- In September clients attended outings to a Car show, Gold Bug Park, Community Church outing, and a trip to the bowling alley. We are planning the upcoming Holiday Events at the Wellness Center and in the T houses. We are looking to

bring back the Thanksgiving Holiday Event at the Fireman's Hall. We are also working on a local camping trip with staff and clients.

CHILDREN'S SERVICES (Angelina Larrigan)

- Sierra Children and Family Services is currently serving 141 clients with SMHS received 15 referrals in September.
- Sierra Children and Family Services has identified two more schools in South Lake Tahoe for Wellness Centers. This will bring the South Lake Tahoe Wellness Center total to 3. Additionally, wellness center services are being expanded at Black Oak Mine Unified School District.
- New Morning is currently serving 24 clients with SMHS and they received three referrals in September.
- Stanford is currently serving 31 clients with SMHS and they received two referrals in September.
- Summitview is currently serving 69 clients and they received five referrals in September.

DBT/FEP Program (Jody Kwachak-Hall)

Tahoe:

- DBT groups are not being provided at this time.
- DBT skills education and practice is done on an individual basis.
