Dear Supervisor,

I am sending this letter to each of the supervisors to give you some background on a matter that I plan to bring up at the July 28th board meeting. Obviously, I have chosen that meeting for a reason; at the following meeting you will be hearing an item on the county's contract with El Dorado Disposal and monetary increases to that contract.

Before that contract is signed, I would like to propose a change to El Dorado County Ordinance 5083 extending the ordinance to the Pollock Pines area. Under that ordinance, the county can require bear proof cans in areas where, "it has been determined by the Environmental Management Department that there is a bear or other access management problem". My community has such a problem, but the County's ordinance doesn't apply to my area. I believe it should.

Attached please find a series of pictures from the last four years of the group trash pickup area at Deep Haven and Forebay Roads in Pollock Pines. This is a location that approximately twenty-six households use as a gathering point so that El Dorado Disposal doesn't have to operate on a series of private roads. Unfortunately, the bears don't care what is public and what is private, they just want a meal. So this means that the unfortunate owner of this property is forced to manage the trash problems of twenty-six households or live with unsightly and unsafe garbage in their yard.

My neighbors and I have tried to work with El Dorado Disposal to resolve this issue, and though they've been polite, communicative, and business

like, their hands appeared to be tied.they have no ability to require their customers to use bear-proof cans, and no provision in their contract to provide the cans if they did.

This is an environmental problem as well as a health and safety problem. I look forward to a positive discussion with all of you on the subject on July 28th and again on August 4th.

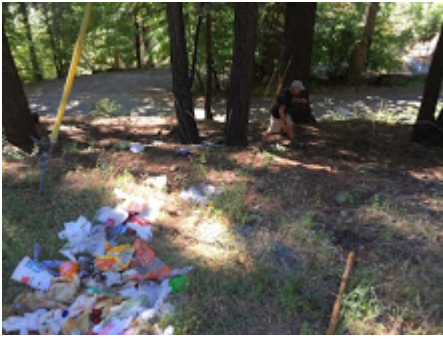

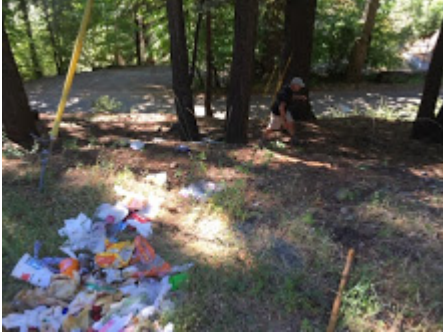
