AGREEMENT FOR SERVICES #545-S1311 AMENDMENT I

This Amendment I to that Agreement for Services #545-S1311, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), City of South Lake Tahoe, a political subdivision of the State of California (hereinafter referred to as "City"), and Moore, Iacofano & Goltsman, Incorporated, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 800 Hearst Avenue, Berkeley, California 94710; (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, Consultant has been engaged by County to provide a comprehensive Parks, Trails and Recreation Master plan for the eastern slope of El Dorado County, also known as the community of South Lake Tahoe, California, in accordance with Agreement for Services #545-S1311, dated April 17, 2013, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of the agreement, hereby amending **ARTICLE II - Term**; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #545-S1311 shall be amended a first time as follows:

ARTICLE II

Term: The term of this Agreement, as amended, shall be for the period of April 17, 2013 through November 1, 2014.

Except as herein amended, all other parts and sections of that Agreement #545-S1311 shall remain unchanged and in full force and effect.


