

AGREEMENT FOR SERVICES #3604
AMENDMENT I

This Amendment I to that Agreement for Services #3604, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and, a G & O Body Shop, Inc., a California Corporation, duly qualified to conduct business in the State of California, doing business as G & O Towing, whose principal place of business is 7515 Green Valley Road, Placerville, CA 95667; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide Vehicle Abatement services for both the Eastern and Western Slopes of El Dorado County on an "as requested" basis for the Sheriff's Office, in accordance with Agreement for Services #3604, dated January 25, 2019, and incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the compensation of said Agreement by replacing Paragraph 5 only, hereby amending the total compensation in **ARTICLE III Compensation for Services**; and

WHEREAS, the parties hereto have mutually agreed to update **ARTICLE XII Notice to Parties**; and

WHEREAS, the parties hereto have mutually agreed to update **ARTICLE XXV Administrator**,

NOW THEREFORE, the parties do hereby agree that Agreement for Services #3604 shall be amended a first time as follows:

ARTICLE III

Compensation for Services:

Total amount of this Agreement for Services shall not exceed \$72,000 for the three (3) year period.

ARTICLE XII



Administrator: The County Officer or employee with responsibility for administering this Agreement is Lance Bryant, Lieutenant, Sheriff's Office, or successor.


Except as herein amended, all other parts and sections of that Agreement #3604 shall remain unchanged and in full force and effect.




