RESOLUTION No. 245-81

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, El Dorado County Ordinance Code Section 7621 authorizes the Board of Supervisors to establish intersection stops by resolution,

NOW, THEREFORE, BE IT RESOLVED that intersection stops are as follows:

- (a) Intersection of County Highway 77 (Pleasant Valley Road) at its intersection with County Highway 99 (Bucks Bar Road) at points of entrance to said intersection stopping westbound traffic on County Highway 77 and northwest bound traffic on County Highway 99. (#30)
- (b) On Hacienda Drive at its intersection with Country Club Drive.
- (c) On Country Club Drive at its intersection with Hacienda Drive stopping westbound traffic only.
- (d) On each intersection of Ponderosa Road, Mother Lode Drive, South Shingle Road and the eastbound Highway 50 off ramp. (Ord. 1935)
- (e) On Starmount Way and Willowdale Drive at their intersection with Pendleton Drive.
- (f) On intersection streets as required intersecting Rainbow Trail between Sly Park Road and Speckled Drive.
- (g) On Fruitridge Road at its intersection with Hassler Road.
- (h) On Hassler Road at its intersection with Fruitridge Road stopping southbound traffic only.
- (i) On Union Ridge Road at its intersection with Hassler Road stopping southbound traffic only.
- (j) On Bucks Bar Road at its intersection with Mt. Aukum Road, except right-turning traffic. (6/5/79, Ord. No. 2006)
- (k) On Grizzly Flat Road at its intersection with Mt. Aukum Road.
- (l) On Mt. Aukum Road at its intersection with Grizzly Flat Road stopping southbound traffic only.
- (m) On Grizzly Flat Road at the intersection with String Canyon Road stopping westbound traffic only.
- (n) On Barkley Road at its intersection with Larsen Drive.
- (o) On Lon Court at its intersection with North Circle Drive.
- (p) On San Bernardino Avenue, No. 2252B, at its intersection with Apache Avenue.
- (q) On Georgia Slide Road at its intersection with Mameluke Hill Road stopping southbound traffic only.
- (r) On Spanish Dry Diggins Road at its intersection with Reservoir Road, stopping eastbound traffic only.
- (s) On Pony Express Trail at its intersection with Sly Park Road stopping eastbound through traffic only. (12/14/76)
- (t) On Kimberly Drive (Road No. 318) at its intersection with Knollwood Drive (8/29/78, Ord. No. 1915)

(v) On Black Bart Avenue at its intersection with Martin Avenue stopping southbound traffic only. (9/5/78, Ord. No. 1917)

(w) On Greenstone Road at its intersection with Green Valley Road. (3/20/79, Ord. No. 1985)

(x) On Breedlove Road at its intersection with Wentworth Springs Road. (6/5/79, Ord. No. 2006)

(y) On Brauer Road at its intersection with Wentworth Springs Road. (6/5/79, Ord. No. 2006)

(z) On Sudbury Road at its intersection with Meder Road. (6/5/79, Ord. No. 2006)

(aa) On Pioneer Hill Road at its intersection with Newtown Road. (6/5/79, Ord. No. 2006)

(ab) On Granite Trail at its intersection with Hazel Street. (6/5/79, Ord. No. 2006)

(ac) On the westbound lane of Cedar Drive at its intersection with Mace Road. (10/2/79, Ord. No. 2029)

(ad) On the eastbound lane of Cedar Drive at its intersection with Fern Avenue. (10/2/79, Ord. No. 2029)

(ae) On Placer Street (Road No. 1891) at its intersection with Church Street (Road No. 1881) stopping east and westbound traffic. (Ord. 205)

(af) On the southbound lane of Cambridge Road (No. 306) at its most northerly intersection with Knollwood Drive (No. 315). (Ord. #3103)

(ag) On all approach legs of Cameron Park Drive (No. 200) and Coach Lane (No. 355) at their intersection.
