Last update April 3, 2012

- Several IT enhancements have been installed and are running successfully, including the new e-mail system, Granicus video broadcasting, Legistar enhancements, applicant tracking system and employee evaluation.
- The board approved issuing an RFP for the acquisition of a new Enterprise Resource Planning (ERP) system and adding positions in support of that effort. Enterprise Resource Planning systems are a comprehensive solution to resource and financial management that includes Human Resources, Payroll, Accounting, Asset Management and other components.

Update – RFP Process

- The RFP was issued and 11 vendors responded.
 - Reviewed by Subject Matter Experts (SME's) and the selection committee
 - Under the terms of the RFP, 3 vendors were advanced to the next Level
- In July, each of these three vendors provided an on-site, all day demonstration to the SME's, selection committee , executive sponsor and others.
- After a debriefing of attendee's the selection committee voted to advance two candidates to the next level.
- The two remaining vendors are now being subjected to additional evaluation.

Update – RFP Process

- The major components of effective project management are in place
 - The executive sponsors are the Auditor/Controller, the CAO and the Chief Information Technology Officer
 - An independent project advisor is assisting the team with the selection process.
 - The Project manager is Acting Assistant IT Director David Russell.
 - Some of the project management team have been identified
 - The project selection committee is Joe Harn, Vern Pierson, Karl Weiland, Laura Roth, Laura Schwartz, Don Ashton, Sue Hennike and David Russell
- The selection process is strengthened by the involvement of a diversity of users, experts and managers. At every decision point, there is strong consensus supporting the process and the outcome.

Other Activities

- In April the county spent a day with Jon Fullinwider, IT expert and county business consultant
 - Focus was on delivering service in a world forever changed and maximizing the supporting role of information technology.
 - The importance of recognizing the need for “get out of the box” approaches to problem solving.
 - Using IT as a solution provider and recognizing IT as an integral part of business decision making at all levels.
- Based on the presentation from Mr. Fullinwider, the focus of the Information Technology Investment Team is being redirected.

Team's Goals

- To provide leadership in improving and enhancing county business practices with the capabilities from information technology investments.
 - Ensuring investments have the capability of enhancing our service delivery.
 - Ensuring departments actively pursue service delivery improvement using the information technology investments
- Develop capability to track and report on the effectiveness of service delivery improvement with quantitative and qualitative measurement.
- Strengthen the process for selecting and implementing IT projects.
- To provide the Board and the public with regular updates

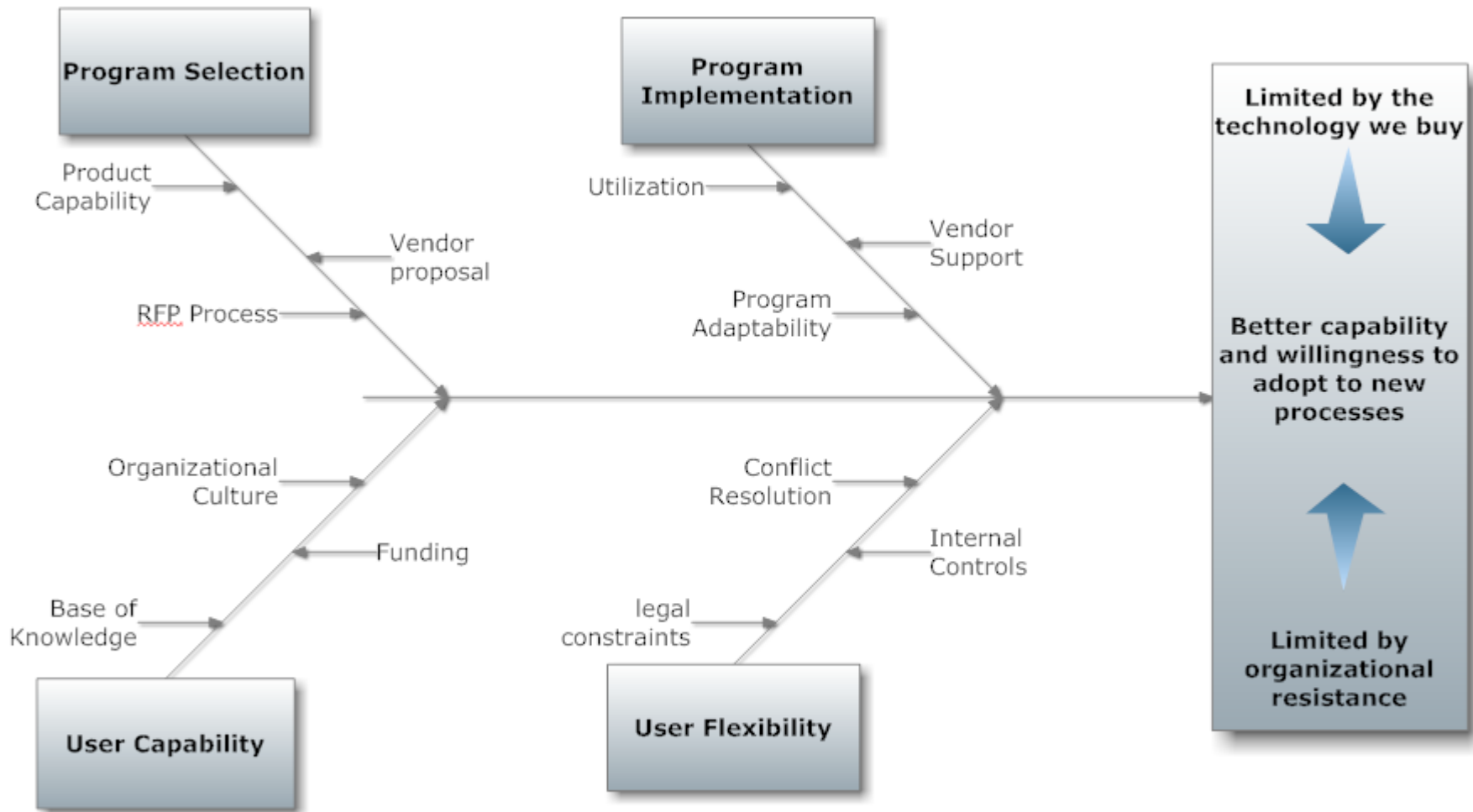
Next Steps
