AGREEMENT FOR SERVICES #214-S1710

This Amendment I to that Agreement for Services #214-S1710, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and National Medical Services, Inc., a Pennsylvania Corporation, doing business as NMS Labs, duly qualified to conduct business in the State of California, whose principal place of business is 3701 Welsh Road, Willow Grove, PA 19090 and whose Agent for Service of Process Incorp Services, Inc. 5716 Corsa Ave Ste 110, Westlake Village, CA 91362-7354 (hereinafter referred to as "Contractor");

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide selected forensic analysis and toxicology services for the El Dorado County Sheriff, Coroner's Division, in accordance with Agreement for Services #214-S1710, dated November 15, 2016, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to extend the term of said Agreement one additional year, hereby amending **Article II: Term**; and

**WHEREAS**, the parties hereto have mutually agreed to increase the not to exceed amount of said Agreement, hereby amending **Article III: Compensation for Services**; and

**WHEREAS**, the parties hereto have mutually agreed to change the contract administrator of said Agreement, hereby amending **Article XII: Notice to Parties** and **Article XXIII: Administrator**; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #214-S1710 shall be amended a first time as follows:

**ARTICLE II**

**Term:** This Agreement shall become effective upon final execution by both parties hereto and shall cover the period of November 1, 2016 through October 31, 2018

**ARTICLE III**

**Compensation for Services:** For services provided herein, County agrees to pay Contractor monthly in arrears and within thirty (30) days following the County's receipt and approval of itemized invoice(s) identifying services rendered. For the purposes of this Agreement, the billing rate shall be as in Exhibit A.

Total amount of this Agreement shall not exceed \$190,000 for the two (2) year period.

**ARTICLE XII**
