WHEREAS, the County of El Dorado has received an application from Kevin Michael Corrigan and Michael Lynn Corrigan as Co-Trustees of the Kevin and Michael Corrigan Living Trust, owners of Lot 24 in West Valley Village Lot 6 & 7 Unit 1, requesting that the County of El Dorado vacate the Storm Drain easement of said property, identified as Assessor's Parcel Number 118-650-001; and

WHEREAS, Department of Transportation has not used said subject easement for the purposes for which it was dedicated and find no present or future need exists for said subject easement and does not object to its vacation, and to that end, has issued a letter to that effect; and

WHEREAS, the Surveyor's Office has determined that said subject easement has not been used for the purpose for which it was dedicated and has no objection to its abandonment and wherein Exhibit A describes the easement to be abandoned and is depicted on Exhibit B; and

WHEREAS, all other existing easements shall remain.

NOW, THEREFORE, BE IT RESOLVED, that from and after the date this Resolution is recorded, said offer for said subject easement is terminated and abandoned and no longer constitutes an offer for easement. In addition, a Certificate of Correction, Modification or Amendment is hereby authorized to be signed and recorded.

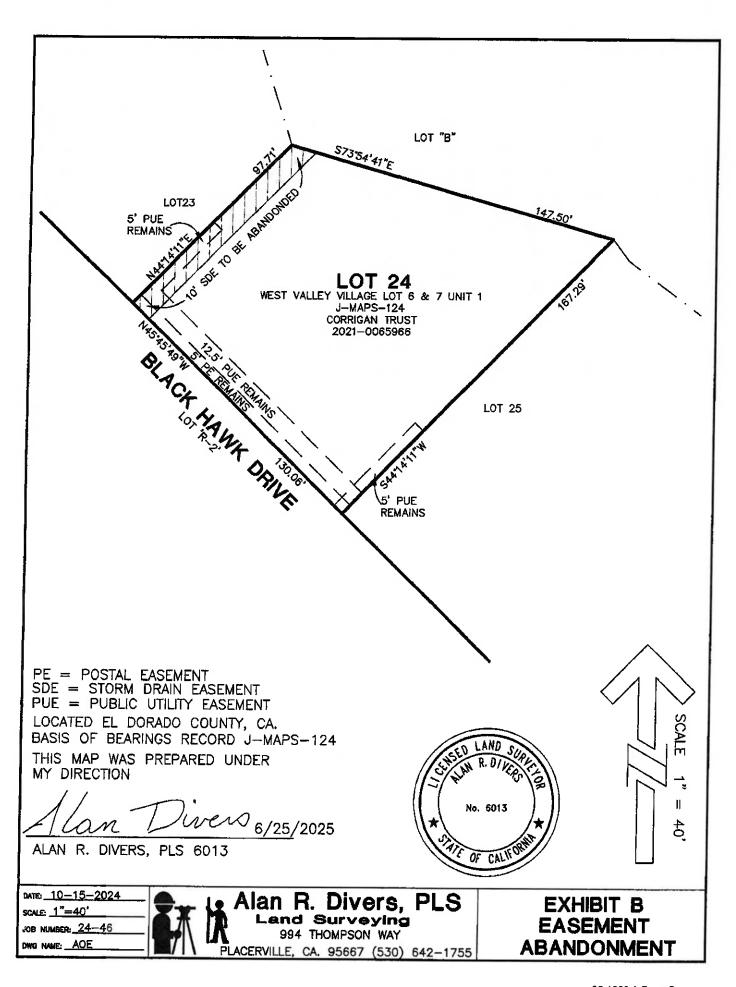

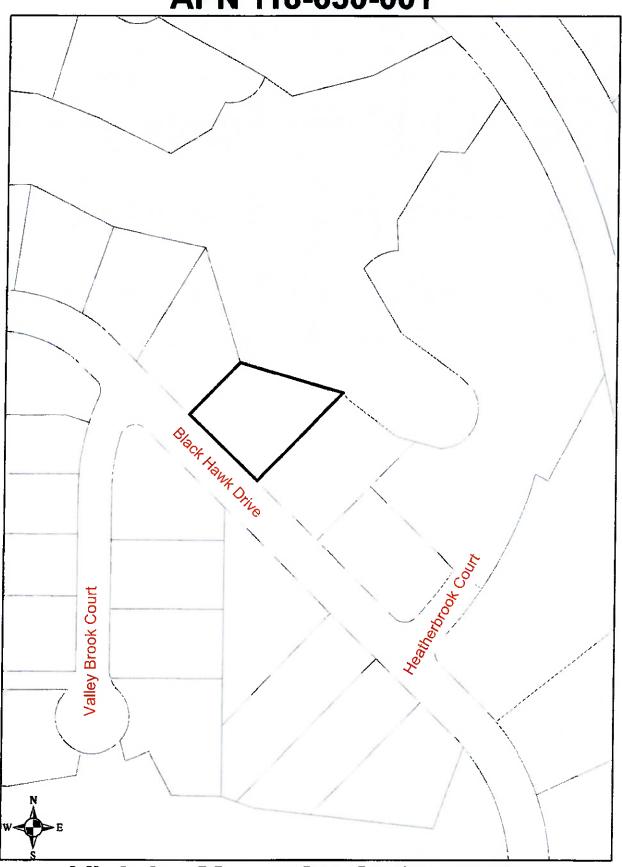
