**PART IV
PROGRAM NARRATIVE**

1. OBJECTIVES

An Application for Federal Aviation Administration Airport Improvement Program funds has been prepared for the following projects proposed to be included in the 2024 Airport Improvement Program at the Placerville Airport, Placerville, El Dorado County, California.

- *Project No. 1 – Design* – Install New AWOS on Existing Tower
- *Project No. 2 – Design* – On-Airport Obstruction Removal – TSS and ROFA

The project descriptions are as follows:

Project No. 1 – Install New AWOS on Existing Tower

A new AWOS is needed to update the existing facilities, which are over 20-years old and require extensive maintenance. Expensive equipment maintenance provides only temporary solutions, which would be eliminated with the new AWOS. This project will include removing AWOS sensors from existing AWOS, installing new AWOS sensors on existing AWOS tower and foundations, installing new cable in existing duct from existing panel at segmented circle to existing AWOS site, and installing new AWOS equipment in the Airport Manager’s Office. The engineering design of this project is included in this application.

Project No. 2 – On-Airport Obstruction Removal – TSS and ROFA

Trees exist in the TSS & ROFA at the Placerville Airport that were identified as obstructions to these surfaces in the AGIS and ALP in 2020. These obstructions will need to be removed. The engineering design of this project is included in this application

2. RESULTS OR BENEFITS EXPECTED

The new AWOS and the removal of obstructions to the TSS and ROFA will provide safety of aircraft operations at the Placerville Airport.

3. APPROACH

Plan of Action - All airport design will conform to Advisory Circular 150/5300-13B, *Airport Design*. Specifications will be prepared based on Advisory Circular 150/5370-10H, *Standards for Specifying Construction of Airports*. All safety requirements as outlined in Advisory Circular 150/5370-2G, *Operational Safety on Airports During Construction* will be included in the Construction Safety and Phasing Plan prepared for this project. The engineering will be performed as follows:

Project No. 1 – Install New AWOS on Existing Tower

Phase 1 – Preliminary

- a) Perform Environmental Studies.
- b) Project Scoping / Preliminary Engineering

Phase 2 - Engineering Design and Preparation of Plans and Specifications

- a) Perform complete engineering design.
- b) Prepare complete plans and specifications for the project, ready for bid.
- c) Prepare Engineer's Report, including engineer's estimate of construction costs for the proposed project, and Construction Safety and Phasing Plan.

Phase 3 - Engineering Support During Bidding and Contract Award

- a) Assist County in distributing final plans and specifications to prospective contractors.
- b) Participate in a pre-bid meeting for all prospective contractors.
- c) Respond to any questions and comments from prospective contractors.
- d) Preparation of required addenda.
- e) Assist County in awarding contract including preparation of Abstract of Bids, evaluation of bids, and preparation of the final Application for AIP funds.

Project No. 2 – On-Airport Obstruction Removal – TSS and ROFA – Design

Phase 1 – Preliminary

Perform Environmental Studies.

Phase 2 - Engineering Design and Preparation of Plans and Specifications

- a) Perform complete engineering design.
- b) Prepare complete plans and specifications for the project, ready for bid.
- c) Prepare Engineer's Report, including engineer's estimate of construction costs for the proposed project, and Construction Safety and Phasing Plan.

Phase 3 - Engineering Support During Bidding and Contract Award

- a) Assist County in distributing final plans and specifications to prospective contractors.
- b) Participate in a pre-bid meeting for all prospective contractors.
- c) Respond to any questions and comments from prospective contractors.
- d) Preparation of required addenda.
- e) Assist County in awarding contract including preparation of Abstract of Bids, evaluation of bids, and preparation of the final Application for AIP funds.

The location and dimensions of the project are shown on the project sketch included as part of this Program Narrative.

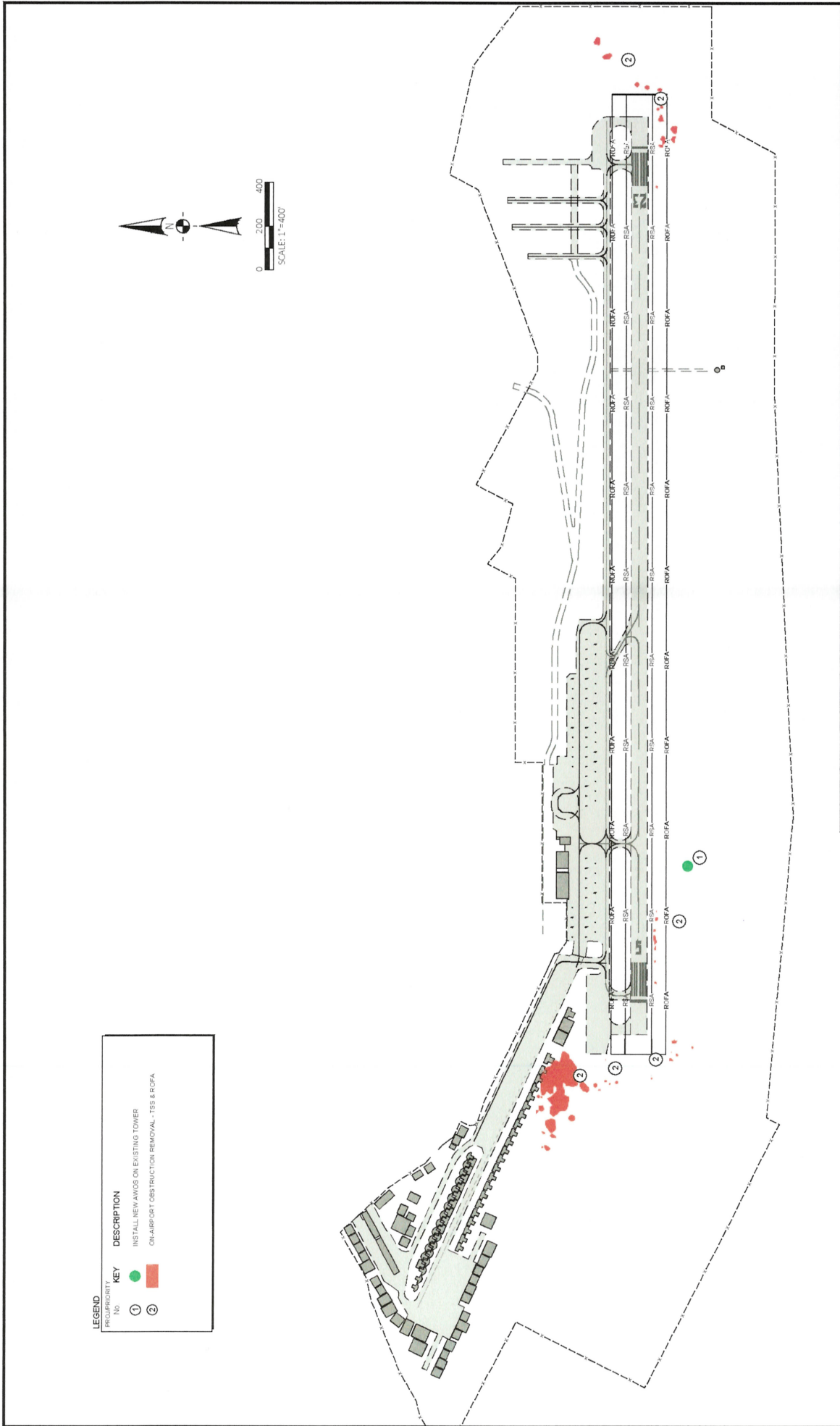

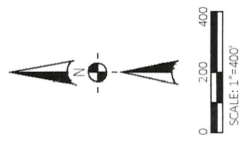

During the performance of this contract, the contractor, for itself, its assignees and successors in interest (hereinafter referred to as the "contractor") agrees as follows:






