## Behavioral Health Division Update Behavioral Health Commission October-December, 2024 Data January 15, 2025, Meeting

## BH DIRECTOR & DEPUTY DIRECTOR UPDATES (Nicole Ebrahimi-Nuyken)

On October 30, 2024, the Department of Health Care Services (DHCS) issued a letter to the Behavioral Health Division. The letter notified the Division that the annual review of the County's compliance with Federal and State regulations, program requirements and contractual obligations conducted by the County Compliance Section (CCS) within Audits and Investigations (A&I) of DHCS on June 26, 2024, resulted in the finding that the BHD has sufficiently demonstrated compliance with all reviewed Federal and State regulations, program requirements and contractual obligations during FY 2023-24. During the compliance review, no deficiencies were identified in the following seven review categories: Availability of DMC-ODS Services, Care Coordination, Quality Assurance and Performance Improvement, Access and Information Requirements, Coverage and Authorization of Services, Beneficiary Rights and Protections, and Program Integrity.


- 18 placed at EDC Telecare PHF

The MHP is contracted with the State to provide Psychiatric Emergency Services to any individual within the boundaries of the County, regardless of insurance or residency status.

## **Psychiatric Health Facility (Chris Kernes/Moriah Weldy)**

- There were **23** Admissions; **18** Admissions were El Dorado County residents and **5** were Out of County residents.
- There were **15** El Dorado County residents discharged; **7** to Home with Support, **0** to Home without support, **0** MHRC/IMD, **0** Board and Care, **3** to ICM T-House, **0** to Shelter, **5** to Other, and **0** to Emergency Department.
- Upon discharge, **13** El Dorado County residents were insured and **2** El Dorado County residents were pending insurance.
- There were **0** Seclusion Episodes, **0** Physical Restraint Episodes (3 minutes), **0** Assaults, **0** Elopements, **0** Medication Errors (**0** medication errors with no patient involvement.
- There were **1** denials of El Dorado County referrals: required oxygen, no electric outlet in sleeping/bedrooms
- Average daily census was **12.87** (range 10 15) with **15.75** average length of stay of days.
- Concurrent Reviews resulting in no medical necessity found. 0



# South Lake Tahoe Alternative Collaboration Services (STACS) (Aria Benham)

South Lake Tahoe clinicians continue to work alongside law enforcement to support them in the field with mental health calls. Aria Benham, Matt Hazelet and Jacob Marquette presented as a panel discussion for Barton Memorial's Community Advisory Committee Meeting. This meeting invites various organizations and key players from the community to have discussions regarding current services and collaborations. The panel discussion was engaging for community members who offered valuable questions for STACS, STACS was able to share statistics on calls for service as well as mental health calls. Jacob Marquette from Barton community clinic shared how he is focusing on substance use disorders, Officer Hazelet and Dr. Marquette work closely together to reduce help reduce barriers for community members to present for substance use services. Dr. Marquette shared the importance of services that address co-occurring disorders and commended EDC BH for supporting LE in the field and connecting community to vital services.

## QUALITY IMPROVEMENT/UTILIZATION REVIEW (Justine Collinsworth)

- The QM team has been working with stakeholders and internal staff to prepare for the roll-out of the Mobile Crisis Benefits. This has included intense focus on workflows and logistical problem solving.
- The MHP and DMC-ODS QM teams are working together, along with our IT and Fiscal team, to prepare for upcoming audits with the External Quality Review Organization. This is intensive and an audit that is different than in years past.

## PATIENTS' RIGHTS ADVOCATE

5150 Hearing (AB2275) This new law became effective on January 1, 2023.

EDCBH has implemented a process to facilitate a due process hearing no later than 7 days from the initial detainment. A Certification Review Hearing is to be held at the ED (MMC/Barton), if a client continues to meet criteria for a 5150, and has been placed on a second hold, until transfer and placement arrangements to a LPS designated facility are completed or the hold is lifted.

5150: A person, as a result of a mental health disorder is a danger to others, or to themselves, or gravely disabled, can be taken into custody for a period of up to 72 hours for assessment, evaluation, and crisis intervention or placed for evaluation and treatment in a facility designated by the county for evaluation and treatment. <u>California Code, WIC 5150</u>

5250: Additional 14 days of intensive treatment related to mental health disorder or chronic alcoholism. <u>California Code, WIC 5250.</u>

5270: After completion of 14-day intensive treatment pursuant to 5250, the person may be certified for an additional 30-days of intensive treatment. <u>California Code, WIC 5270.15.</u>

## **PROGRAM ACTIVITY UPDATES**

## SUBSTANCE USE DISORDER SERVICES (SUDS) (Salina Drennan)

- Prevention: The Youth Action Council adult leadership team is meeting weekly. Adult and youth leadership meet together to work on social media for the YAC twice monthly, and we have an in-person youth-adult meeting once a month. Right before Christmas break, the youth launched a social media kindness challenge at Union Mine High School. The purpose was to engage youth in kindness surrounding mental health and SUD.
- The main focus of the YAC right now is working with community partners to host an Opioid Prevention Event to screen a film called Fentanyl High. It is a documentary made by youth, for youth, parents, and community members to watch and be educated/informed on the dangers of fentanyl among youth. This is a multi-agency coordination event. The film is set to be screen in March at the

Placerville Cinema, and will consist of the documentary, a speaker panel, and local community resources in the lobby. More information to come as we have different planning committees working diligently to make the event possible.

## ADULT OUTPATIENT SERVICES (Jody Kwachak-Hall (SLT); Jessica Sinnetos/Christianne Kernes (WS))

Tahoe:

- Adult Outpatient Clinicians and Mental Health Workers actively work with clients to provided MH services in the office, in clients' homes, by telephone, and by telehealth. The Clinicians and Mental Health Workers provide services in community settings.
- The Tahoe Team has developed a comprehensive Group Schedule that incorporates a broader range of interventions that are suited to the populations with whom we work.

West Slope:

 Individualized services are provided to adults, age 18 years and older, who meet criteria for Specialty Mental Health Services by a multidisciplinary team of Psychiatrists, Nurses, Psychiatric Technicians, Mental Health Clinicians, and Mental Health Workers/Aides. Services include assessments, medication evaluations and support, clinical psycho-social and co-occurring assessments, individual therapy, group therapy, and rehabilitative and case management services and supports. Services are delivered in the Clinic, in clients' place of residency, in the community or via telehealth. The West Slope has begun to fill positions for Clinicians with the utilization and help of a contracted agency.

There have been several Wellness Center participants who have begun to volunteer regularly and consistently in the Wellness Center in various roles such as thoughtfully engaging participants in activities to encourage socialization, decorating for the seasons and kitchen and overall clean-up activities, stating that they want to "give back" because they have benefitted from attending and have received so much from their participation at the Wellness Center.

## ICM Activities: (Jody Kwachak-Hall / Jessica Sinetos / Chris Kernes)

**Tahoe:** December: With the sunny weather in the first two weeks of December, a group of six clients went on an outing to the beautiful Emerald Bay where they learned about photography and were able to take pictures of the natural scenery. Seasonal Cooking group included 10 clients learning how to make Minestrone soup that they very much enjoyed eating! Clients volunteered their services at the Animal Shelter where they engaged in animal therapy through play time with the cats and by taking the dogs on a walk. Other special activities included games of pickle ball, disc golf in Carson City, a trip to the library where clients obtained library cards and learned about using this resource. Another group was an outing to Kahle Community Center where clients learned about the facility. Groups in Games and Socializing, Boundary Setting, Resiliency & Mindfulness, and Coping with the Holidays supported clients in gaining skills to navigate this sometimes challenging and hectic time of the year. A holiday party was enjoyed by clients where Behavioral Health staff offered a variety of pizzas, salad, desserts, fun and socializing.

### West Slope:

ICM clients continue to participate in various Wellness Center activities and groups. Clients are participating in and enjoying staff led group discussions and activities focused on self-care, independent living skills and other psychoeducation groups focused on healthy, coping skills, and peer support. ICM team is working on reimplementing some volunteering opportunities for clients in our wellness center to bring some heartfelt pride in where the clients enjoy spending time and feel safe. ICM staff have implemented more group-based activities in the Wellness Center to engage clients in healthy socialization and communication while getting to know one another. There has been a lot of client and peer participation in the new group being held in the Wellness Center and client and peers continue to like the new fun activities being offered. ICM staff are starting a new group in the middle of January to help clients prepare for work readiness or volunteering.
