Re: Year in Review 2024

Dear Chair Turnboo:

In compliance with the By-Laws of the El Dorado County Commission on Veterans Affairs, it is my pleasure to submit this end of year report to appraise the Board of the Commission's activities during the previous (2024) calendar year.

In the year, the Commission addressed a number of issues. Following is a description of the most significant and the Commission's activities concerning them:

#### **Commission Meetings**

In January 2023, Ken Welch was elected as Chair and Todd Smith as Vice Chair of the El Dorado County Veteran Affairs Commission for 2023 and 2024. In November 2024, Ken Welch stepped down as Chair and Roger Reynolds was elected as Chair with Todd Smith remaining as Vice Chair.

#### **TOT (Transit Occupancy Tax) Committee**

This committee meets at least 8 of 12 months of the year, on the second Thursday of the month at 11:30 a.m. before the general meeting of the Veteran Affairs Commission; exceptions are the beginning of the Mini Grant Cycle which typically begins at 11:00 a.m.

TOT Allotted funds are managed by County of El Dorado Health and Human Services with oversight by the CAO. Mini-Grant TOT funds and grant applications continue to be managed by the El Dorado Community Foundation. Services office (instead of an extra-help General Trainee) was recommended by the TOT Committee and approved by the VAC at the July 11, 2024 VAC meeting.

Note: The Mini Grants have been funded with funds left with the Foundation due to Covid

## **Transportation Committee**

• We are pleased to report that in August, the Military Family Support Group (who receives TOT allotment) have used their funds to support provide transportation needs to veterans for medical appointments.

#### **Budget Committee**

We are pleased to report that we are working with HHSA for partial funding of a new position in the VSO office. This will allow for more veterans to be assisted in the future. This position was filled on January 25, 2025.

### **Education and Employment Committee**

• Continued review and support for Lake Tahoe Community College for use of TOT funds.

### Social Media (proposed Committee on the revised By-Laws)

• Social Media Facebook page for the Commission reaching over 1410 followers. From across many different age groups. 43.70% - men 56.30% - women. Hoping to reach 2000 in the future.

#### Veterans Memorial Building

- Veterans Memorial Building House Council continues to do an exceptional job of managing the building ensuring that use is complying with Facility Use Agreement #255-O1611, effective 03/17/17-03/17/22.
- The Eagle Scout Project for honoring the fallen soldiers from El Dorado County has been completed and is on display at the Veterans Building in Placerville
- The building has been repaired from the flood of 2023 and is open and being used.

#### **Department of Veteran Services:**

- January The VSO and HHSA interviewed to fill the Veterans Service Representative position.
- February The VSO and VSR II attended the winter training conference in Sacramento. The Veteran Services Office is fully staffed with 4 VSRs.
- March VA Health Care Eligibility became available for veterans without having to apply for disability compensation first.
- April The Senior Office Assistant for the Veteran Services Office became accredited with Cal Vet to further help the VSRs. Senate Bill 1124, which aims to protect veterans from predatory practices by addressing the issues of "claims shark" was proposed to the senate.
- May VoterVoice was introduced in relation to Senate Bill 1124 and Assembly Bill 46 to help veterans engage in the legislative process.

- June VFW 10165 started serving breakfast at the VMB the second Sunday of each month. El Dorado Veteran Resources (EDVR) held a "Come and Get It" event to clean out their storage and give items to veterans and their families in need. EDVR also started a food giveaway to help veterans and their families through the summer and fall months on the second and fourth Wednesday of each month. David Zelinsky won Senior of the Year award from El Dorado County for his work in assisting the homeless populations and veterans in the community.
- July The VSO had his VSR II attend the summer training conference in Sacramento. New VSR became accredited with Cal Vet and will be able to further help the team serving veterans. HHSA and the VA TOT Committee asked the VAC to approve the .50 FTE Office Assistant Position at the Veteran Services Office. The VAC voted to approve this position.
- August Senior Office Assistant began training with Administrative Technician to learn how to run VAC meetings.
- September The Stand Down was held on Friday September 13<sup>th</sup> and Saturday September 14<sup>th</sup>, which was successful in informing veterans of the services they might be eligible for.
- October The VSO and his VSRs attended all three fall virtual training conference.
- November The Veteran Services Office opened a new Office Assistant position with help from HHSA and the VA TOT.
- December The Veteran Services Office started interviewing to fill the new Office Assistant position. Assembly Bill 53 was introduced that would exempt military retirements and Survivors Benefit Plan from state taxes.

**Vet Mentorship Program-** Volunteer David Zelinsky, another tireless veteran advocate, provided assistance to veterans in the Veterans Treatment Court Program, developing process and outreach. Eventually, he will be transitioning out of this role to mentor his replacement.

**Senior of the Year Award** – David Zelinsky was awarded the Senior of the Year Award for El Dorado County in June 2024 for his work in assisting the homeless population and veterans in the community.

**Thanksgiving Dinner** – Georgetown hosted a Thanksgiving dinner for veterans and their families at no charge. MFSG worked with District Church to give out Thanksgiving dinners to veterans and their families at no charge as well.

Ralph M. Brown Act - Training session made available to commissioners.

Additionally, this Commission has been in contact with the members of your Board to keep them appraised of issues of concern to the veteran community as well as continuing to keep in touch with Service Office, the veteran's service organizations and veteran's legislation at the state and federal levels.

The Commission extends its sincere thanks to the entire Board for its active support of the Commission and the veteran's community.
